**SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
PLEASANT GROVE RANGER DISTRICT**

TIBBLE FORK AREA CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited in the** area as described in this order, all lands affected are located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect from June 17th and is being extended from the end of December 2016 to the end of February 2017 or until the construction work is completed.

- 1. Being in or on the area and trail as described** below and as shown on attached map. This includes all uses. **[36 CFR 261.53(e)]**

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Tibble Fork Reservoir along State Route 144 across the dam south east along the high water mark to Forest Service road 085 west to State Route 144 as shown on attached map. Tibble Fork trail (Forest Service trail #041) to the intersection with Forest Trail #173, as shown on attached map, located in Township 4 South, Range 2 East, Sections 7, 8 and 17 all located within the Salt Lake Base Meridian, as shown on map.


PURPOSE:

Purpose of the Closure is to provide for health and public safety while construction crews and heavy equipment are working on the Tibble Fork Dam Reservoir restoration project.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the areas affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months imprisonment. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
