### PALISADES CREEK SPECIAL CLOSURE

ORDER NO. 17-95-194

PURSUANT TO 36 CFR 261.50(a) & (b), THE FOLLOWING ACTS ARE PROHIBITED ON THESE FOREST LANDS IN THE TAHOE NATIONAL FOREST, AS SHOWN ON EXHIBIT 1:

ON THE PALISADES CREEK TRAIL #14E14, AND THE HEATH FALLS OVERLOOK TRAIL #14E21.

1. POSSESSING OR USING MOTORIZED VEHICLES. 36 CFR 261.55(b).
2. POSSESSING OR USING A SADDLE, PACK, OR DRAFT ANIMAL. 36 CFR 261.55(c).

CAMPING IN THE SE 1/4, NE 1/4, Section 16, T.16 N., R.14 E., MDM.  
36 CFR 261.58(e).

CAMPING IN EXCESS OF ONE (1) NIGHT IN:  
36 CFR 261.58(a).

1. THE SW 1/4, Section 16, T.16 N., R.14 E., MDM.
2. THE S 1/2, NW 1/4, Section 16, T.16 N., R.14 E., MDM.
3. THE SW 1/4, NE 1/4, Section 16, T.16 N., R.14 E., MDM.

THE FOLLOWING PERSONS ARE EXEMPT:

1. ANY FEDERAL, STATE, OR LOCAL OFFICER, OR MEMBER OF AN ORGANIZED RESCUE OR FIRE FIGHTING FORCE IN THE PERFORMANCE OF AN OFFICIAL DUTY.
2. PERSONS WITH A PERMIT OR WRITTEN AUTHORIZATION, THIS PERMIT MUST BE IN POSSESSION AT ALL TIMES WHILE UTILIZING ANY OF THESE ROADS.

THESE PROHIBITIONS ARE IN ADDITION TO THE GENERAL PROHIBITIONS CONTAINED IN 36 CFR PART 261.


