SPECIAL CLOSURE

PROHIBITIONS:

Pursuant to 16 USC 551 and Title 36 CFR 261.50(a) and (b), the following acts are prohibited on all National Forest System lands as described in this Order (the “restricted area”) and as depicted on the attached map, hereby incorporated into this Order as Exhibit A, within the Pecos/Las Vegas Ranger District, Santa Fe National Forest, San Miguel County within the State of New Mexico.

1. Entering into or being upon the described area which is closed for the practice of traditional and cultural purposes. **36 CFR 261.53(g)**

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this closure order:

1. Persons with a Forest Service permit specifically authorizing the prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Residents in the area accessing private property via a restricted Forest Service road, to the extent necessary to gain access to their property.

RESTRICTED AREA:

The restricted area includes the following areas and the entire length of all of the following Forest System Roads (FSR) on NFS land and the lands surrounding those roads as described by Township, Range, and Section:

1. Holy Ghost Canyon FSR 122
2. Holy Ghost Campground
3. Holy Ghost Group Area
4. Holy Ghost Trailhead
5. Holy Ghost Trail# 283 in its entirety (T.18N, R.12E, Sections 20,29,32,33).

PURPOSE:

The purpose of this closure order is to protect the privacy of traditional and cultural ceremonies by the Jemez Pueblo.

IMPLEMENTATION:

1. This Order will be in effect at 3:00 PM, Monday August 22, 2016 and shall remain in effect until 12:00 PM midnight of August 24, 2016, or until rescinded, whichever occurs first.
2. Any violation of this prohibition is punishable as a Class B misdemeanor by a fine of not more than \$5,000.00 for individuals and \$10,000.00 for organizations, or by imprisonment for not more than six (6) months, or both. [Title 16 USC 551, Title 18 USC 3559, 3571, and 3581]
3. This Order supersedes, rescinds, and replaces any previous orders prohibiting the same acts covered by the Order.
