CT6.42# Yarding and Skidding Methods: Applies to all Payment Units.

CT6.47# Slash Treatments Requirement: Slash plans and Specifications for Yarding and / or Decking slash on Landings and Temporary Roads applies to all Payment Units. Whole tree/ Leave Tops Attached Yarding applies to all Payment Units.
