

# PUBLIC NOTICE

## TAHOE NATIONAL FOREST

### OREGON CREEK RESTRICTED USE AREA

Order No. 17-95-202

PURSUANT TO TITLE 36 CFR 261.50(a), I PROHIBIT ALL OF THE FOLLOWING ACTS ON NATIONAL FOREST LANDS WITHIN THE OREGON CREEK RESTRICTED USE AREA AS SHOWN ON EXHIBIT 1:

1. CAMPING. 36 CFR 261.58(e).
2. BEING PUBLICLY NUDE. 36 CFR 261.58(j).

FURTHER, I PROHIBIT THE FOLLOWING ACT OUTSIDE OF DEVELOPED RECREATION SITES WITHIN THE OREGON CREEK RESTRICTED USE AREA:

1. BUILDING, MAINTAINING, ATTENDING, OR USING A FIRE, CAMPFIRE, OR STOVE FIRE. 36 CFR 261.52(a).


THE EXTERIOR BOUNDARIES OF THE OREGON CREEK RESTRICTED USE AREA ARE AS SHOWN ON EXHIBIT 1; GENERALLY DESCRIBED AS, BEING LOCATED WITHIN THE EAST 1/2 OF SECTION 28, T.18 N., R.8 E., MDM. FURTHER DEFINED AS THAT AREA BOUNDED ON THE WEST BY A LINE GENERALLY 1/4 MILE WEST OF AND PARALLELING STATE HIGHWAY 49 AND BOUNDED ON THE NORTH, EAST AND SOUTH BY THE SECTION LINES OF SECTION 28.

THESE PROHIBITIONS ARE IN ADDITION TO THE GENERAL PROHIBITIONS IN 36 CFR 261.
