Cabinet Ranger District

Trail Report 8/1/16

- ***St. Paul Lake, Trail #646:*** (7/3) Trail has been cleared to the lake. The campsites on the lake shore are available
- ***Buck Lake and Lost Buck Pass, Trail #912 (Swamp Creek):*** (4/26) Trail cleared to the last creek crossing approximately ½ mile from Buck Lake.
- ***Wanless Lake, Trail #924:*** (7/1) Trail is cleared to the upper lake.
- ***Engle Peak, Trail #926:*** Unknown
- ***Engle Lake, Trail #932:*** (6/30) Trail has been cleared. There is a large flat rock across the trail on the switchbacks down to the lake that may be an obstacle for stock.
- ***Devils Club, Trail #966:*** This trail will not be cleared this year, It has multiple large logs and lots of brush but is still hikeable.
- ***North Fork Bull River, Trail #972:*** (5/18) Trail has been cleared. Be advised the trail is narrow and brushy and may not be appropriate for stock use. Be advised road #2722 is washed out at the junction of road #410. This adds approximately 1.5 miles to the hike.
- ***Middle Fork Bull River, Trail #978:*** (6/9) Trail has been cleared to 1.5 miles past the Wilderness Boundary. Be advised the trail is narrow and brushy and may not be appropriate for stock use. Be advised road #2722 is washed out at the junction of road #410. This adds approximately .75 miles to the hike.
- ***Dad Peak, Trail #987:*** Unknown.
- ***Moran Basin, Trail #993:*** Trail cleared (7/18/16)
- ***Chicago Peak:*** The road is drivable to the entrance point. Be advised the road is rough and a 4-wheel drive high clearance vehicle is recommended.
