GENERAL INFORMATION:

- Note: Provide your **TAX IDENTIFICATION NUMBER (TIN) in the signature block of the bid form.**
- Contract provision B(T)8.64 – Debarment and Suspension Certification (6/06) requires Purchasers to obtain certifications from its lower tier participants regarding debarment, suspension, ineligibility and voluntary exclusions after award of the contract. Purchasers shall keep the certifications on its lower tier covered transactions on file until sale termination date, and will provide a copy to the Forest Service at the written request of the Contracting Officer. An example of this certification is shown following the instructions for page 101 of this contract.
- Corporations submitting an offer under this solicitation must include form AD-3030-FS Representations Regarding Felony Conviction and Tax Delinquent Status For Corporate Applicants.
- A Prewrite conference is required annually before the commencement of work. The Purchaser shall arrange for this meeting with the Contracting Officer (C6.10).
- As per B4.213, Periodic Payment Schedule, periodic payment will be required. The approximate periodic payment date is 04/07/19. The final date will be based on the award date of this timber sale.
- Deposit for Reconstruction Engineering Services(C5.213#) is included in this contract. The deposit amount is \$22,481.07 and must be paid by the end of the first full Normal Operating Season(February 15, 2017).
- In ALL Units, Non-sawtimber Products meeting utilization standards in A2 shall either be decked at the landing or removed, at the option of the Purchaser (C2.211#). Payment for this product shall be made as per C4.225. If Purchaser elects to remove this product, then payment shall be made after the product is presented for scaling.
- A snow plowing allowance of \$64,800.00 has been included because winter operations requiring 10” of settled snow and/or frozen ground are specified in Units 15, 15A, 24, 24A, 25A, 25B, 26, 27, 94A, 96, 97, 97A, 98, 98A, 98B, 98C, and 98D.
- Units 49, 94, and 101 have been appraised as Skyline Units BUT the purchaser has the option to adverse tractor skid these units. Tractor skidding in Units 94 and 101 will only be allowed over 10” of settled snow and/or frozen ground(C6.4#).
- Units 90 and 95 are specified as Timber Subject To Agreement (C2.11#). These units are optional and will only be included upon written agreement between Forest Service and Purchaser.
- Slash Disposal Deposit will be paid by Purchaser by lump sum payment, by cutting unit upon completion of skidding activities (C4.228#). Total collection is in the amount of \$20,386.00

12. There has been an allowance made in the appraisal for (1) 16' Powder River Gate and one installation. Temporary roads that intersect with open public use roads will need temporary activity barricades per requirements of (C5.41#).
13. Road Maintenance and Surface Replacement Deposits were calculated by the total volume of both Sawtimber and Non-sawtimber.
14. Washing of equipment prior to entering the Sale Area is required in order to prevent the spread of noxious weeds (C6.351#), an allowance for this is NOT made in the appraisal.
15. This sale will be sold by the ton and 100% weight scaled with split pricing for Sawtimber and Non-sawtimber.
16. The appraisal for the sale was based on Sawtimber (road maintenance rates are calculated with Non-sawtimber volume included).
17. The environmental document that approved this sale is the Griffin Creek II Resource Management Project Decision Notice Signed September 26, 2013.
18. This contract contains Skyline Units that may require artificial guybacks and tailholds and intermediate supports. An appraisal allowance was not given for these potential requirements.
19. In cutting units in which logging is substantially completed by September 30th or any time outside the Normal Operating Season, purchaser's slash disposal responsibilities shall be completed within the first 30 days of the next summer Normal Operating Season(C6.7#)
