The purpose of this amendment is to address questions, and to provide photos of the trailers being replaced for reference.


- Aluminum trailers are requested, a combination of steel framed, with aluminum skin will be accepted.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.






