SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
SALT LAKE RANGER DISTRICT

TEMPORARY AREA AND BOARDWALK CLOSURE

PROHIBITION:

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), in order to provide for public safety, **the following acts are prohibited** on the area and boardwalk on National Forest System area described in this order. All lands affected are located on the Salt Lake Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect beginning September 19, 2016 through November 18, 2016

1. **Going into or being upon any area** as described below and shown on the attached map.
[36 CFR 261.53 (e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIPTION:

The area closure begins 100 yards below the dam upstream to the Terraces bridge and includes all parking areas on both sides of the Mill Creek road (excluding the main Mill Creek road) and includes the Mill Creek Boardwalk located in Township 1 South, Range 2 East, Sections 27 and 28 all within the Salt Lake Based Meridian. See attached map.

PURPOSE:

Purpose of the Closure is to provide for public health and safety while construction crews remove the Mill Creek dam and downstream portion of the boardwalk.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
