On 11/08/2016, at 11:00 AM, sealed bids will be opened in the Forest Supervisor's Office, Attn: Timber Mgmt., Room 238D, P.O. Box 1270, Hot Springs, AR 71902 for the Browns Creek sale. This sale is located in T2N, R17W, Section 1; T3N, R17W, Sections 17-22, 25-30, & 33-36; T3N, R18W, Sections 24, 25, 27, 34, & 35; Perry County, Arkansas. Timber sale Contract 2400-6T will be used. The termination date for this sale is 10/31/2022.

There are 3.69 miles (5.94 kilometers) of specified road reconstruction. A specified road construction cost of \$352,001.00 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 21,683 CCF. The Forest Service encourages potential bidders to make their own inspection and estimate prior to bid submission.
