This sale is located in Warrants 552, 565, 566, 579, 580, Pleasant Township, Warrants 533, 534, 553, 554, 563, 564, Mead Township, Warren County. Timber sale Contract 2400-6T will be used. The termination date for this sale is 06/30/2019. This is a small business set-aside sale.

This sale will be preferentially awarded to a qualified small business concern. In the absence of any bids from a self-certifying qualified small business concern, the sale will be readvertised without restriction on the size of bidders.


