



ORDER NO. 2008-06

**ORDER OF THE FOREST SUPERVISOR
RESTRICTING THE USE OF ROADS, TO WIT:
GREEN MOUNTAIN NATIONAL FOREST - VERMONT**

Under the authority of the Act of Congress dated June 4, 1897, as amended (16 U.S.C. 551), and pursuant to the Secretary of Agriculture's Regulations set forth at 36 CFR Part 261, Subpart B (36 CFR 261.50(a) and (b)), the following acts and omissions are prohibited on the Green Mountain National Forest, Vermont, said area being described and designated as shown on the map set forth at Exhibit A, which is attached hereto and made a part hereto:

1. Operating a vehicle carelessly, recklessly, or without regard for the rights or safety of other persons, or in a manner or at a speed that would endanger or be likely to endanger any person or property. **36 CFR 261.54(F)**
2. Operating a vehicle on Forest System roads when posted closed. **36 CFR 261.54(e)**
3. Operating a vehicle on Forest System roads in violation of Vermont State Motor Vehicle Laws (Title 23 Vermont Statutes Annotated). **36 CFR 261.54(d)**
4. Parking in violation of posted instructions. **36 CFR 261.58(g)**

THESE RESTRICTIONS ARE NECESSARY TO PROTECT NATIONAL FOREST SYSTEM ROADS AND PUBLIC SAFETY. THEY ARE IN ADDITION TO THE GENERAL PROHIBITIONS SET FORTH IN 36 CFR PART 261. THE PROHIBITIONS WILL BE IN EFFECT FROM THE DATE OF THIS ORDER UNTIL SPECIFICALLY WITHDRAWN BY TERMINATION ORDER OF THE FOREST SUPERVISOR.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Any Federal, State, or local officer or member or an organized rescue or firefighting force in the performance of an official duty [36 CFR 261.50(e)(4)]; and,
2. Persons with a valid permit signed by the District Ranger or Forest Supervisor in their possession that specifically authorizes the otherwise prohibited act or omission [36 CFR 261.50 (e)(1)].

Violation of these prohibitions are punishable by a fine of not more than \$5000 for an individual or \$10,000 for and organization, or imprisonment for not more than six (6) months, or both, under authority of Title 16 U.S.C. 551, Title 18 U.S.C. 3559 and 3571.
