**ORDER OF THE FOREST SUPERVISOR  
RESTRICTING ALLEGHENY NATIONAL FOREST, TO WIT:**

**BUZZARD SWAMP AREA**

**ALLEGHENY NATIONAL FOREST  
PENNSYLVANIA**

Under the authority of the Act of Congress dated June 4, 1897, as amended (16 USC 551) and the Secretary of Agriculture's regulation 36 CFR 261.50 (a) and (b), the following act is prohibited on the Allegheny National Forest lands and waters within the Buzzard Swamp Area, located within Elk County, Commonwealth of Pennsylvania:

**Any and all entry is prohibited into the area set aside as a refuge and propagation area**  
*SEE EXHIBIT* [36 CFR 261.53 (b)]

**Possessing or using a saddle, pack, or draft animal off of designated roadways**  
*SEE EXHIBIT* [36 CFR 261.55 (c)]

THIS RESTRICTION IS NECESSARY TO PROTECT PUBLIC HEALTH AND SAFETY AND FOREST RESOURCES. THEY ARE IN ADDITION TO THE GENERAL PROHIBITIONS SET FORTH IN 36 CFR PART 261. THE PROHIBITIONS WILL BE IN EFFECT FROM THE DATE OF THIS ORDER UNTIL SPECIFICALLY WITHDRAWN BY TERMINATION ORDER OF THE FOREST SUPERVISOR.

*Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:*

1. Persons with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer or member or an organized rescue or firefighting force in the performance of an official duty.

*Violation of any of these prohibitions is punishable by a fine of not more than \$5000 or imprisonment for not more than six (6) months, or both, under authority of Title 16 USC 551, Title 18 USC 3559 and 3571.*

This update is to ensure that consistent and accurate information is being portrayed to the public and also to reflect the recent change in Forest leadership staffing.

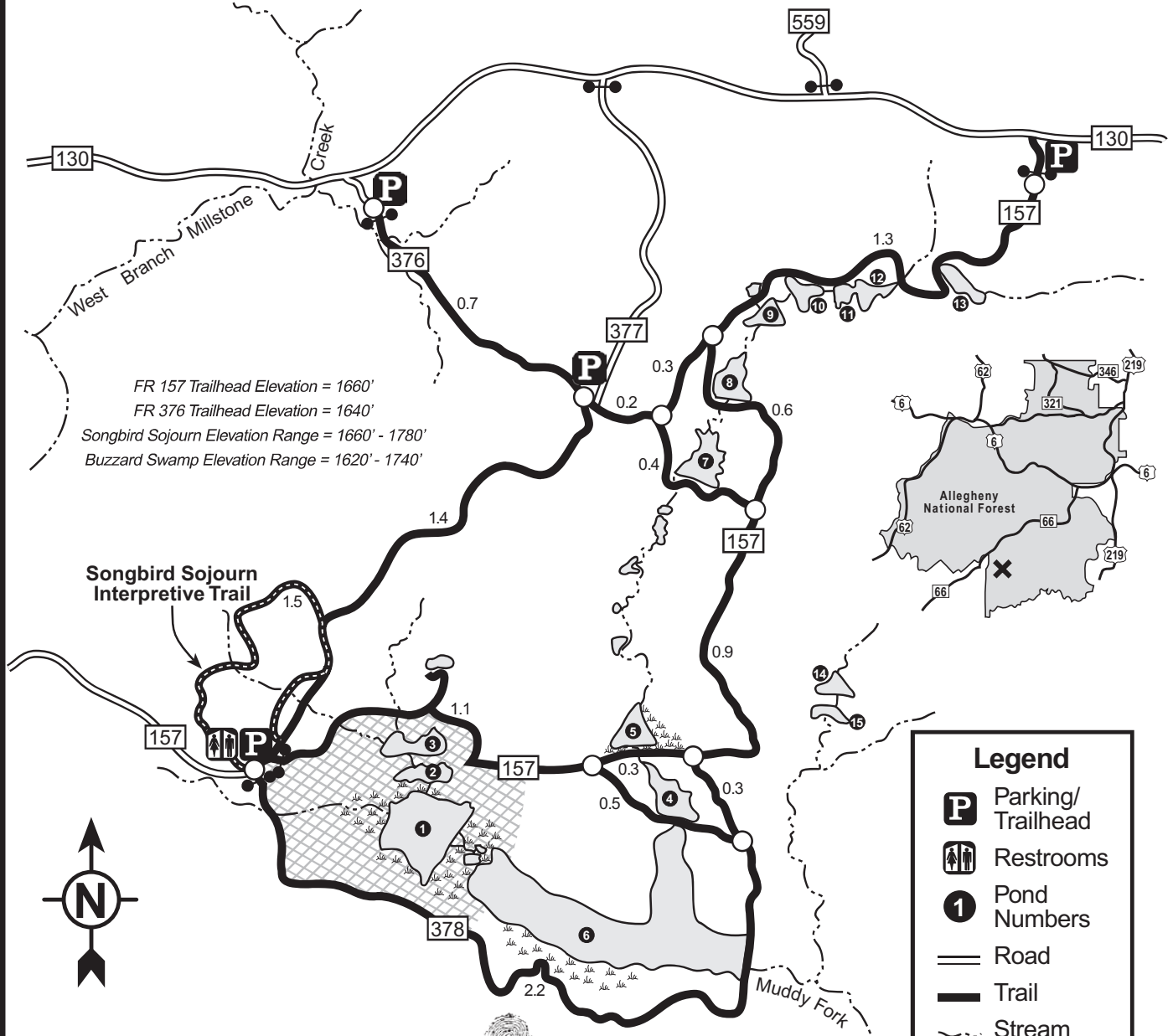
## **Enforcement Plan**
