ORDER
STAGE 1 FIRE RESTRICTIONS
COCONINO NATIONAL FOREST
RED ROCK RANGER DISTRICT

Pursuant to 16 U.S.C. 551, and 36 CFR § 261.50(a), the following acts are prohibited on all National Forest System lands within the Red Rock Ranger District of the Coconino National Forest, in the following counties within the state of Arizona: Coconino and Yavapai. The restricted area is depicted on the attached map, hereby incorporated into this Order as Exhibit A.

PROHIBITION:

1. Building, maintaining, attending or using a fire, campfire, charcoal, coal, or wood stove; **36 CFR § 261.52(a)**.
2. Smoking, except within an enclosed vehicle or building; **36 CFR § 261.52(d)**.

EXEMPTIONS:

1. The following developed recreation sites are exempted from the prohibition:
 - a. Cave Springs Campground
 - b. Chavez Group Site Campground
 - c. Clear Creek Campground
 - d. Manzanita Campground
 - e. Pine Flat Campground
 - f. Crescent Moon cabin
 - g. Grasshopper Point Day Use Area
2. The use of petroleum-fueled stoves, lanterns or heating devices providing such devices meets the fire underwriter's specifications for safety is allowed.
3. Any Federal, State or Local Officer or member of an organized firefighting force in the performance of an official duty.
4. Persons with a Forest Service permit specifically authorizing the prohibited act or omission.

AREA DESCRIPTION:

This area affects National Forest System lands within the exterior boundary of the Red Rock Ranger District of the Coconino National Forest.

PURPOSE:

This Order is necessary to protect public health and safety due to the fire danger.

IMPLEMENTATION:

1. This Order becomes effective at 8:00 A.M. June 2nd, 2017 and shall remain in effect until August 15th, 2017 or until rescinded, whichever occurs first.
2. This Order rescinds, replaces and supersedes any previous Orders prohibiting the same acts covered by this Order in that area addressed in Exhibit A
