SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
HEBER-KAMAS RANGER DISTRICT

TEMPORARY TRAIL CLOSURE

PROHIBITION:

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System trail described in this order. The trail affected is located on the Heber-Kamas Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect June 27, 2017 through December 31, 2017.

1. **Being in or upon the Little South Fork trail (Forest Service trail #067)** This includes all pedestrian, equestrian, bicycle and any type of motorized vehicle as described below and shown on attached map. [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIPTION:

The Little South Fork trail (Forest Service trail #067) is closed from the intersection with Forest Service road #70096 north to the intersection with Forest Service trail #068 located in Township 4 South, Range 7 East, Sections 4, 9, 16, and 21 all within the Salt Lake Base Meridian. As shown on the attached map.

PURPOSE:

Purpose of the closure is to provide for public health and safety while timber crews are cutting and removing timber as part of the Little Dip salvage sale.

IMPLEMENTATION:

1. This Order will be in effect when signed on June 27, 2017 will remain in effect until December 31, 2017 or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
4.
