TEMPORARY ROAD CLOSURES

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following act is prohibited** on the National Forest System road as described in this Order. The road affected in this Order is located all within the Ogden Ranger District, Uinta-Wasatch-Cache National Forest. This order is effect July 28, 2017 through November 15, 2017.

1. **Being on or up the Forest Service road #26015** as described below and shown on attached map. [36 CFR 261.55(f)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIBED:**

Forest Service road #26015 from the intersection with the Liberty-Avon road (Forest Service road #20132) running northwest to its end point (approximately 0.2 miles in length), located in Township 8 North, Range 1 East, Section 29 all within the Salt Lake Based Meridian as shown on the attached map.


**PURPOSE:**

Purpose of the closure is to prevent any further property damage that is being caused by unauthorized off road travel.

**IMPLEMENTATION:**

1. This Order will be in effect when signed July 28, 2017 and shall remain in effect through November 15, 2017 or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than 6 months imprisonment. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7).

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads or trails) covered by this Order.
