SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
PLEASANT GROVE RANGER DISTRICT

SILVER LAKE FLAT SPILLWAY/AREA CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** in the National Forest System area as described in this order. The Silver Lake Flat spillway and area affected in this order are located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect August 4, 2017 through August 4, 2021.

1. **Being in the spillway/area of Silver Lake Flat Reservoir** as described below and as shown on attached map. [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Silver Lake Flat Reservoir dam spillway being in the fenced and buoyed areas surrounding the inlet of the spillway, the spillway shaft and the spillway outlet pool located in Township 4 South, Range 3 East, Section 6 all within the Salt Lake Base Meridian, as shown on map.

PURPOSE:

Purpose of the Closure is to provide for health and public safety due to hazards in these areas.

IMPLEMENTATION:

1. This Order will be in effect when signed August 4, 2017 and shall remain in effect through August 4, 2021 or until rescinded.
2. Attached map shows the areas affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months imprisonment. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
