## Brian Head Fire Trail and Road Closure

### A. PROHIBITIONS

Pursuant to 16 U.S.C. 551 and 36 CFR 261.50, it is prohibited to be upon the road and trails described in this Order, located within the Cedar City Ranger District, Dixie National Forest, which are closed for safety due to wildland fire and wildland fire recovery.

**It is prohibited to be upon the roads and trails described below, which are closed for the protection of Public Health and Safety. 36 CFR 261.54(e); 261.55(a).**

### B. EXEMPTIONS

Pursuant to 36 CFR 261.50(e), the following are exempt from this order.

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

### C. AREA DESCRIBED

The following trails and road are closed until September 30, 2017, or until this Order is rescinded:

Forest Roads: 049, 1952, 1951, 3023, 3027, 3026, 2380, and 048 (from the Forest boundary to Sidney Valley overlook).

Forest Trails: 32032, 32040, 32033, 32043, and 32000.1.

See map attached hereto as Exhibit A, which is incorporated herein by reference.

### D. PURPOSE

The purpose of this Order is to protect public health and safety during the Brain Head Fire and post fire hazards.

### E. IMPLEMENTATION

1. This Special Order implementing Area Closure Restrictions is effective on Wednesday August 2<sup>nd</sup> at 8 A.M. and shall remain in effect until October 31, 2017 or until rescinded, whichever is sooner.

2. Exhibit A, Map, Definitions are attached and incorporated into this ORDER.

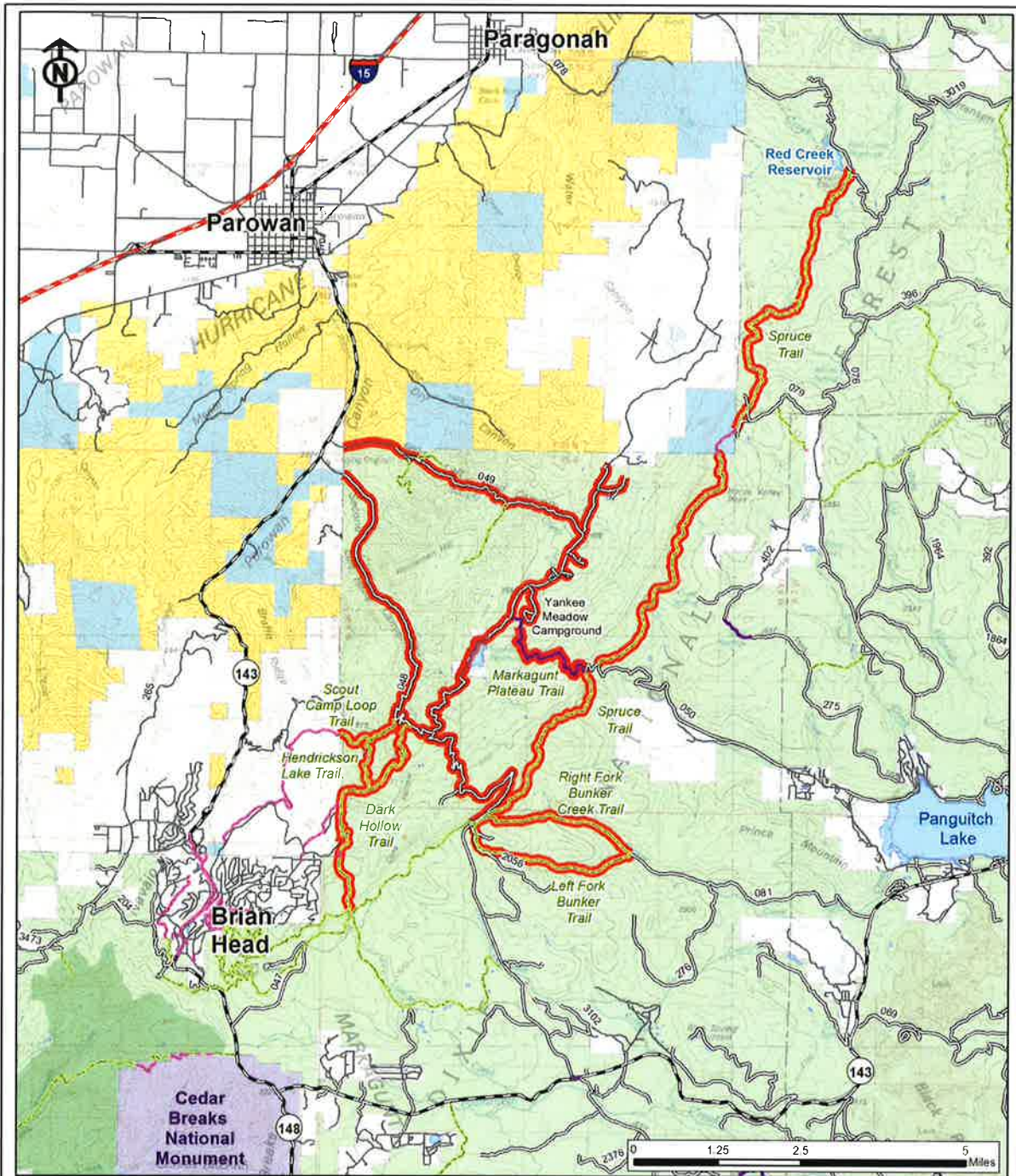
