

ORDER NO. 17-05-801
EMERGENCY CLOSURE
KLAMATH NATIONAL FOREST

Pursuant to 36 CFR 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Ukonom Ranger District of the Klamath National Forest. This Order is effective from August 23, 2017, until the Orleans Complex Fire is declared out.

1. Entering or being within the Orleans Complex Fire Closure Area. The Closure Area begins at the intersection of the Ukonom Ranger District and Happy Camp Ranger District Boundary and the Klamath River, then continues southerly along the eastern edge of the Klamath River to its intersection with State Highway 96, then continues southerly along the eastern edge of State Highway 96 to its intersection with the Klamath River, then continues southerly along the eastern edge of the Klamath River in Section 9, Township 12 North, Range 6 East to its intersection with State Highway 96, then continues southerly along the eastern edge of State Highway 96 to its intersection with southern edge of Section 33 in Township 12 North, Range 6 East, Mount Diablo Basin meridian, then continues east along the section line to its intersection with the Ukonom Ranger District and Salmon River Ranger District Boundary, then continues northerly along the western edge of the Ukonom Ranger District and Salmon Ranger District Boundary to its intersection with the Ukonom Ranger District and Scott River Ranger District Boundary; then continues northerly along the Ukonom Ranger District and Scott River District Boundary to its intersection with the Ukonom Ranger District and Happy Camp Ranger District Boundary, then continues northerly and then westerly along the western and then southern edge of the Ukonom Ranger District and Happy Camp Ranger District Boundary to its intersection with the northern edge of Section 19 in Township 14 North, Range 7 East, Mount Diablo Basin meridian, then continues east along the section line to its intersection with the Ukonom Ranger District and Happy Camp Ranger District Boundary, then continues southwesterly along the eastern edge of the Ukonom Ranger District and Happy Camp Ranger District boundary back to its starting point, as shown on the attached map.

2. Being on the National Forest System roads listed below and shown on the attached map.
 - a. Forest Road No. 13N11 (Sandy Bar Road) from its intersection with Forest Road No. 14N01 (Ten Bear Road) continuing easterly to its terminus at Forest Road No. 15N17 (Camp Three Road).
 - b. Forest Road No. 15N17 (Camp Three Road) from its intersection with Forest Road No. 15N17C (Camp Three Road) continuing northerly to its intersection with Forest Road No. 14N01 (Ten Bear Road).
 - c. Forest Road No. 14N01 (Ten Bear Road) from its intersection with Forest Road No. 13N08 (Ukonom Mountain Road) continuing easterly to its terminus at Forest Road No. 15N17 (Camp Three Road).
 - d. Forest Road No. 12N52 (Rogers Creek Road) from its intersection with Forest Road No. 12N44 (Roger Davis Road) continuing easterly to its terminus at Forest Road No. 15N17 (Camp Three Road).

3. Being on the National Forest System trails listed below and shown on the attached map.
 - a. Forest Trail No. 5832 (Wooley Creek Trail).
 - b. Forest Trail No. 5824 (Black Mountain Trail)
 - c. Forest Trail No. 5819 (Stanshaw Trail).
 - d. Forest Trail No. 5802 (Ten Bear Trail).
 - e. Forest Trail No. 5828 (Haypress Trail).
 - f. Forest Trail No. 5821 (Let'er Buck Trail).

4. Entering or using the Developed Recreation Sites listed below as shown on the attached map.
 - a. Stanshaw Trailhead.
 - b. Wooley Creek Trailhead.
 - c. Ten Bear Trailhead.
 - d. Haypress Trailhead.


Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Owners or lessees of land in the area to the extent necessary to access their property.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 USC 551 and 18 USC 3559, 3571, and 3581.
