Forest Order #06-07-01-17-04-02

Emergency Road and Trail Closures for Health and Safety – Desolation Fire

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), the following acts are prohibited on National Forest System Roads and Trails described in this order within the administrative boundaries of the Ochoco National Forest, and as depicted on the attached map, hereby incorporated into this order as “Attachment A”.

PROHIBITION

1. Being on National Forest System Roads. *36 CFR § 261.54(e)*
2. Being on National Forest System Trails. *36 CFR § 261.55(a)*

ROAD CLOSURE DESCRIPTION:

The closed roads consist of all National Forest System Roads that lie within the Forest Boundary as described below.

NFS road 27 from where it intersects NFS road 2745. Thence east along NFS road 27 to a point where it intersects NFS road 2730-250.

NFS road 2700-500 from where it intersects NFS road 27 to end.

TRAIL CLOSURE DESCRIPTION:

The following trail is closed to public access:

Wildcat Trail #833. Section of trail from the junction of Belknap Trail #833A to the Wildcat North Trailhead.

EXEMPTIONS

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with written authorization by a Forest Officer, which specifically authorizes the otherwise prohibited act. The issuing Officer may include such conditions as are considered necessary for the protection of the area, or for the promotion of the health, safety, or welfare of its users. The decision will be based on risks involved. See Exhibit 2 for a permit example.
2. Any Federal, State, or local Officer, or member of an organized rescue or firefighting force in the performance of an official duty.

This Order becomes effective from the date signed, and will remain in effect for one month or until rescinded, whichever comes first.

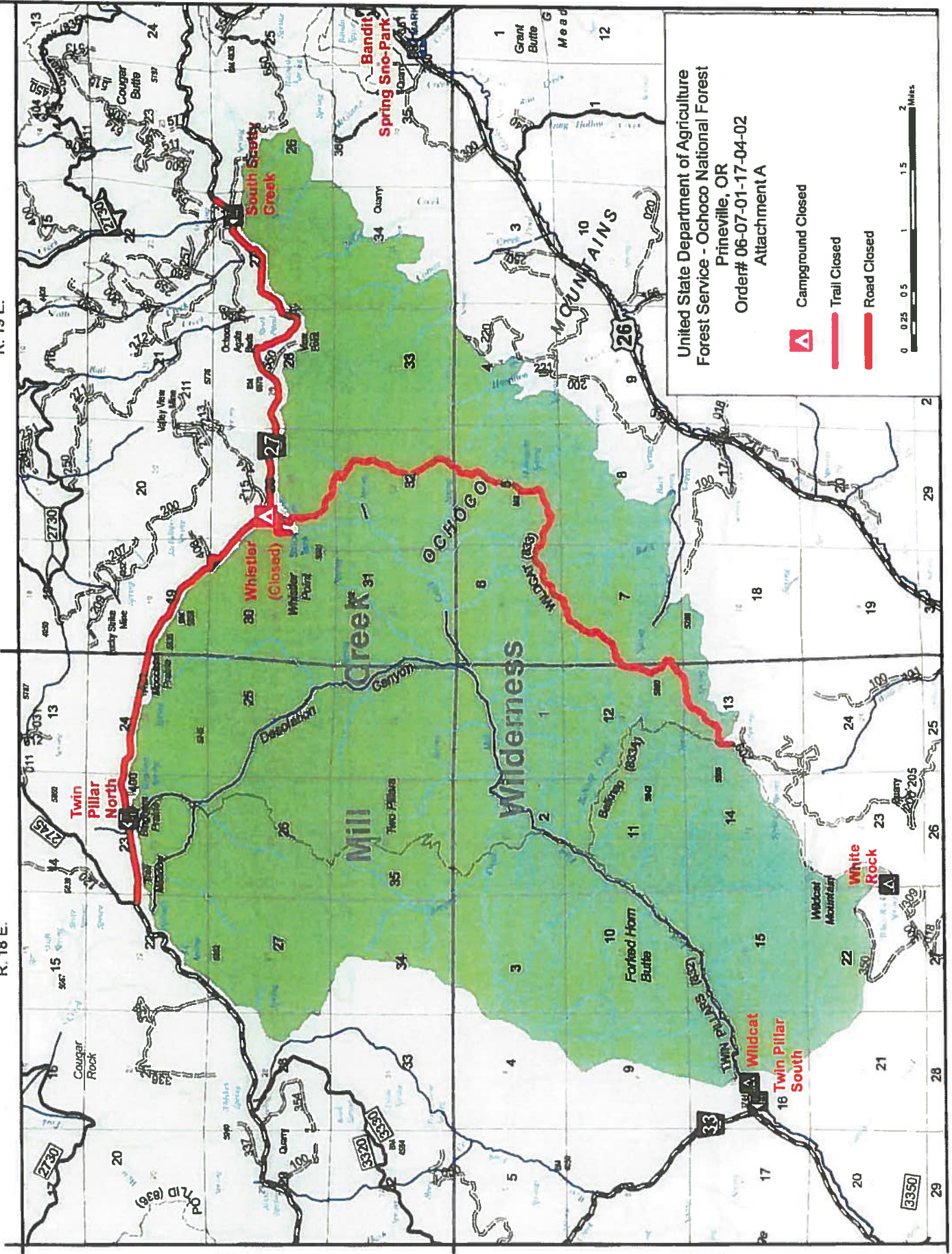
