FOREST ORDER
OCCUPANCY AND USE
ALCOHOL PROHIBITION

Pursuant to 16 USC § 551 and 36 CFR § 261.50 (a) and (b), the following act is prohibited in the Three Pools Alcohol Prohibition Area described in this order within the administrative boundaries of the Willamette National Forest. This order will become effective upon signature, and will remain in effect until modified, rescinded or June 30, 2019.

PROHIBITION:

1. **Possessing an alcoholic beverage as defined by Oregon State law.**
36 CFR § 261.58 (bb)

THREE POOLS ALCOHOL PROHIBITION AREA:

- All closures are contained within Township 8S., Range 4E., Sections 34, in Marion County.
- The order applies to the Three Pools Day Use Area contained within the boundaries as described:
 - Beginning at the intersection of Road 2207 and 2207-214, due south to the north edge of the Little North Santiam River Trail (#3338).
 - Southeasterly along the north side of Little North Santiam River Trail (#3338) until the SE corner of the SE $\frac{1}{4}$, SW $\frac{1}{4}$, NW $\frac{1}{4}$, NE $\frac{1}{4}$, of T.8S, R.4E, Sec. 34.
 - North to the southern edge of Road 2207.
 - Westerly along the south side of Road 2207 to the intersection of Road 2207-214.

EXEMPTIONS:

Order Number 06-18-04-17-05


16 U.S.C. §551, 18 U.S.C. §3559, & §3571

Pursuant to 36 CFR §261.50 (e), the following persons are exempt from this Order:

- (1) Any person with a permit specifically authorizing the otherwise prohibited act or omission.
- (2) Any Federal, State or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

This order shall be effective upon signature, and will remain in effect until rescinded.

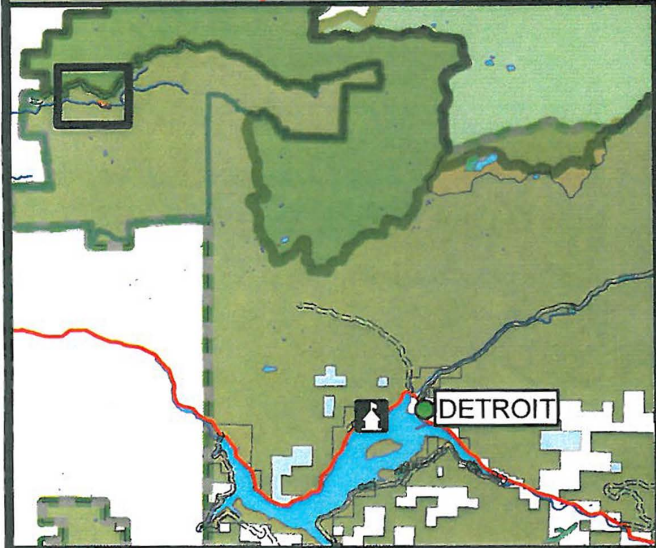





