**NATIONAL FOREST OCCUPANCY AND USE REGULATIONS**

Pursuant to Title 16 United States Code (U.S.C.) § 551 and 36 Code of Federal Regulations (C.F.R.) § 261.50 (a), the following acts are prohibited on National Forest System lands within the Clear Creek Ranger District of the Arapaho National Forest that are located in Clear Creek County herein referred to as the "Restricted Area". The Restricted Area is defined as within one-quarter mile of the Guanella Pass Scenic and Historic Byway also known as Clear Creek County Road 381, from Forest Boundary south to the summit of Guanella Pass located in Township 4 South (T4S), Range 74 West (R74W), sections 19, 20, 29, 30, 31 and 32; T5S, R74W, sections 5, 6, 7, 8, 18, 19, 20, 29 and 30; T5S, R75W, sections 13 and 24, 6th P.M. The Restricted Area also includes portions of the Leavenworth Road, NFSR 248.1, and the Silver Dollar Lake Road, NFSR 243.3D (formerly known as the Naylor Lake Road) as depicted on the attached map, hereby incorporated into this Order as Closure Order map (Exhibit A).

The purpose of this Order is to ensure visitor safety; assure the protection of resources; address sanitation; and preserve the visual quality of the area.

**PROHIBITIONS:**

1. Camping within the Restricted Area. 36 CFR § 261.58(e) (i.e., Title 36, Code of Federal Regulations, Part 261).
2. Building, maintaining, attending, or using a fire, campfire or stove fire within the Restricted Area. 36 CFR § 261.52(a).
3. Being in the area between 10:00 PM and 6:00 AM. 36 CFR § 261.58(u).  
EXCEPT: Persons using the Mount Bierstadt trail #711  
Persons who are camping or visiting a person(s) camping in a Forest Service designated and provided campground in that area
4. Parking or leaving a vehicle in violation of posted instructions in the Restricted Area. 36 CFR § 261.58(g).  
EXCEPT: Persons parking at the summit of Guanella Pass as depicted on Closure Order map  
Parking at designated parking sites

**EXEMPTIONS:**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited
2. Persons traveling/driving through on the Guanella Pass Road – Clear Creek County Road 381
3. Persons traveling/driving through on the Silver Dollar Lake Road (National Forest System Road (NFSR) 243.3D)
4. Persons traveling/driving through on the Leavenworth Road (NFSR 248.1)
5. Persons camping in a Forest Service developed campground.
6. Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

This Order will be in effect when posted, March 1, 2018, and will remain in effect until February 28, 2019 or until rescinded, whichever occurs first.

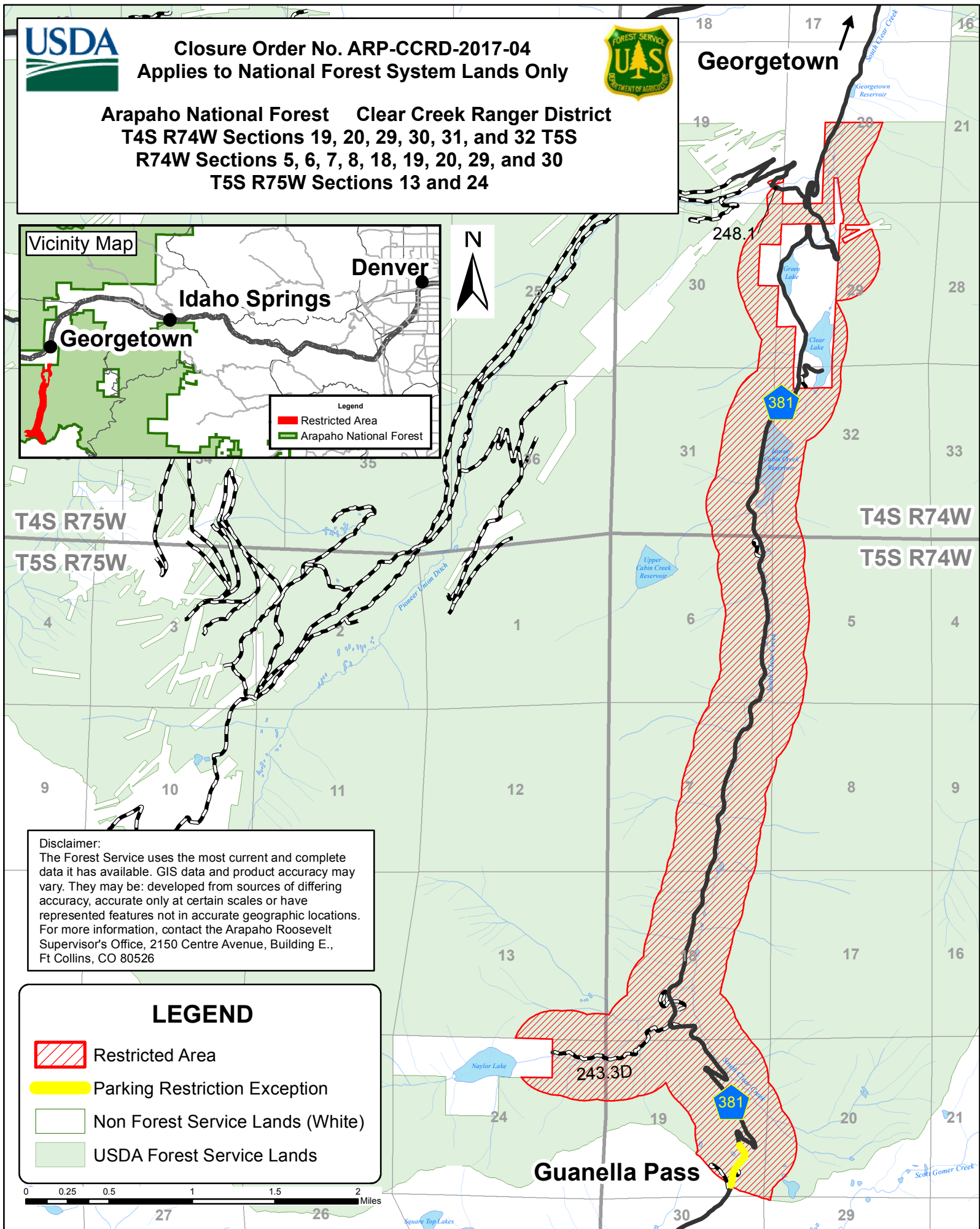
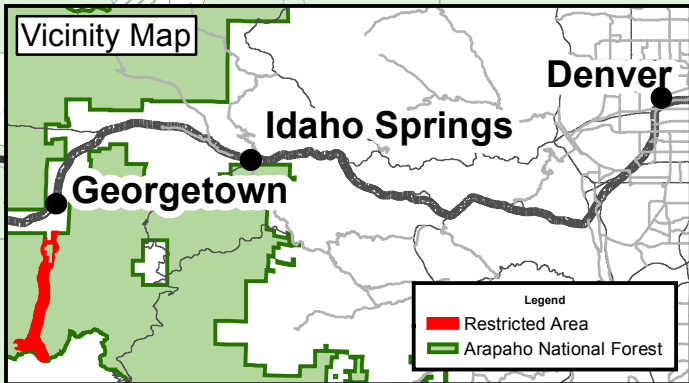
