RULES AND REGULATIONS: The following rules and regulations apply to Anderson Pond Fishing Event

1. Participant age limit is 2 to 12 years. NO EXCEPTIONS!
2. Bank and shore fishing only. NO BOATS!
3. No horseplay by participants, sponsors, or volunteers will be tolerated around lakeshore.
4. No exposed fish hooks will be allowed except at lakeshore. In the interest of safety, please remove hooks from lines while the rods/poles are being transported to and from lakeshore.
5. Limit of 5 fish per participant. Bass must be 10" in length.
6. Parents or chaperones may handle fish. They can cast only for children if needed. All other fishing (holding the rod, reeling the fish, etc) must be done by kids!
7. A parent, legal guardian or named responsible party must sign the release of liability form, and accompany and supervise the children during the event. Groups shall provide one chaperone for every three children.
8. Participants must bring their own fishing gear to the event. Gear should be name-tagged. One rod or pole per participant.
9. Participants are encouraged to bring their own bait for catfish and bream.
10. Chaperones and participants are expected to cooperate with event sponsors.
