**PUMPHOUSE WASH ORDER  
*STAGE III TEMPORARY AREA CLOSURE FOR PUBLIC HEALTH AND SAFETY  
DUE TO HIGH FIRE DANGER***

**COCONINO NATIONAL FOREST**

Pursuant to 16 U.S.C. 551, 36 CFR § 261.50(a), and 36 CFR § 261.50(b), the following acts are prohibited on all National Forest System lands within the Coconino National Forest, in the following counties with the state of Arizona: Yavapai and Coconino. The restricted area is depicted on the attached map, hereby incorporated into this Order as Exhibit A.

**PROHIBITION:**

1. Going into, being upon, or using the restricted area in any way. The restricted areas including all roads, trails, camping areas, and lands. Authority: 36 C.F.R. § 261.52(e); *see also* 36 C.F.R. §§ 261.53(e), 261.54(a), 261.54(e), 261.55(a), and 261.57(a).
2. The prohibitions concern all activities in the area described in this Order, including but not limited to: operating a motor vehicle, all-terrain-vehicle, and/or a motorcycle; hiking/walking; bicycling; camping; fuel-wood retrieval; and operating a drone.

**EXEMPTIONS:**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with a Forest Service permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or Local Law Enforcement Officer or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Residents may access their private property via closed Forest Service roads only to the extent necessary to access such property.

**AREA DESCRIPTION:**

This area affects National Forest System lands within the exterior boundary of the attached map of the Pumphouse area. From the junction of I-17 and Forest Road (FR) 253, west to FR 253E across Pumphouse wash to the Hwy 89A junction including these roads is closed. Oak Creek Vista will remain open. From north of the Oak Creek Vista, head west to 89A to section 26 (AZ State Land), go east along the Forest boundary to I-17.

**PURPOSE:**

This order is necessary to protect public health and safety due to fire danger.

**IMPLEMENTATION:**

1. This Order becomes effective at 1200 AM, May 23, 2018 and will remain in force until rescinded or until August 1, 2018, whichever occurs first.
2. This Order rescinds, replaces and supersedes any previous Orders prohibiting the same acts covered by this Order in that area addressed in Exhibit A.

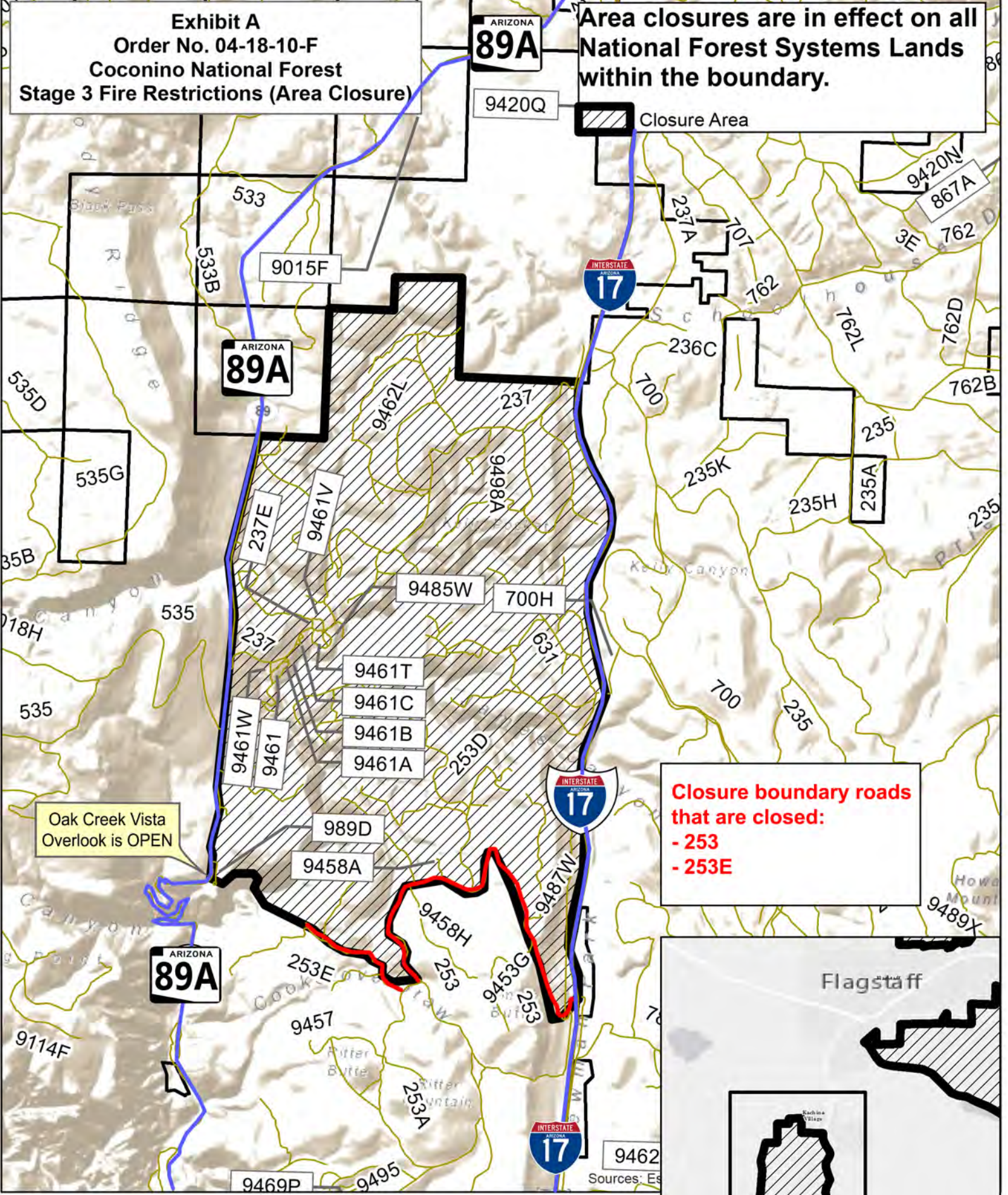
