This report is a general description of the broader area; all conditions are subject to change.

Remember to "Know Before You Go."

Always bring a map and compass, and be prepared for any conditions on the roads and trails.

Seasonal Advisory: The summer travel season began on May 21. Motor vehicle use maps (MVUMs) are available online at <https://www.fs.usda.gov/detail/whiteriver/recreation/?cid=stelprdb5328680> or at district offices. MVUMs show forest routes that are designated as open or restricted to different types of motor vehicles. MVUMs list road opening and closing dates. Several roads remain closed until June so be informed! Expect high-elevation trails and roads to be slick and muddy in spring and early summer. If you encounter a muddy road or trail please turn around and wait until the route dries. Riding on muddy routes can cause permanent road and trail damage.

Food Storage & Camping: Visitors at Meadow Lake Campground, Meadow Ridge Campground, Meadow Lake Picnic Area, or Spruce Picnic Area must store food in a bear-resistant container or inside vehicles in sealed containers. Responsible Forest Use: Responsible use by all visitors is key to a sustainable recreation system. Follow these tips to ensure you protect the places you love to play:

- Stay on designated roads, trails, and areas as identified on the motor vehicle use map.
- Be respectful of other road and trail users.
- Respect property boundaries and know what uses are allowed if you enter non-Forest Service property.
- Do not widen trails by going around obstacles and do not create shortcuts.
- Avoid wet, muddy trails.
- Cross streams only at designated fords.

Stage 1 Fire Restrictions for the entire White River National Forest go into effect at 12:01 AM on **Friday, June 15th**.
