

**FOREST ORDER****USDA FOREST SERVICE  
PIKE and SAN ISABEL NATIONAL FORESTS****NATIONAL FOREST OCCUPANCY AND USE RESTRICTIONS**

Pursuant to Title 16, United States Code, Section 551, 36 C.F.R., Section 261.50(a), the following act is prohibited on National Forest System lands within the following areas of South Platte, South Park and Pikes Peak Ranger Districts of the Pike National Forest, Douglas, El Paso, Jefferson, Park and Teller Counties, State of Colorado, hereinafter referred to as the Restricted Areas. The Restricted Areas are depicted and shown on the attached maps hereby incorporated into this Order as Exhibits A, B and C. The Restricted Areas are further described in the attached tables, also hereby incorporated into this Order as Tables A, B and C.

This purpose of this Order is to protect natural resources and provide for public health and safety.

Pikes Peak Ranger District

- **Rainbow Fall Area** (Colorado Highway 67 to Rampart Range Road): T. 10 S. R. 68 W. Secs. 19, 29, 31, and portions of Sec. 17, 18, 20, 29, and 32; T. 10 S. R. 69 W. Secs. 23, 24, 25, 26, 27, 28, 35, 36 and portions of Secs. 12, 13, 14, 15, 16, 17, 19, 20, 21, 22, 29, 30, 33, and 34.
- **Manitou Park Recreation Area:** T. 11 S. R. 69 W. sec 15, and portions of Sections 10, 11, 14, 22, 23, 26, 27, 34, 35, and 36; T. 12 S. R. 69 W. portion of Sections 1, 2, and 3.
- **Mount Herman Road Corridor Area:** T. 11 S. R. 67 W. section 30 and portions of Sections 7, 16, 17, 18, 19, 20, 21, 29, 31 and 32; T. 11 S. R. 68 W. sections 25, 26, 33, 34, 35, and 36 and portions of Secs. 23, 24, 27, 28, 29, and 32; T. 12 S. R. 68 W. sections 3, 4, and 5 and portions of Secs. 1 and 2.
- **Rampart Reservoir Recreation Area:** T. 12 S. R. 68 W. sections 27, 34, and 35, and portions of sections 14, 15, 21, 22, 23, 24, 25, 26, 28, 29, 33, and 36; T. 13 S. R. 68 W. portions of sections 2 and 3.
- **South Rampart Range Road Area** (including the Rampart Reservoir Recreation Area): T. 12 S. R. 68 W. sections 27, 33, 34, and 35, and portions of sections 7, 8, 9, 10, 14, 15, 16, 17, 19, 20, 21, 22, 23, 24, 25, 26, 28, 29, 30, 31, 32, and 36; T. 12 S. R. 67 W. a portion of section 31; T. 13 S. R. 68 W. section 3, and portions of sections 1, 2, 4, 5, 9, 10, 11, 12, 13, 14, 23, 24, and 25; T. 13 S. R. 67 W. section 19, and portions of sections 6, 18, 20, 21, 28, 29, 30, and 31.
- **Gold Camp Road and Old Stage Roads in El Paso County:** T. 14 S. R. 67 W. Portions of Sections 21, 28, 29, 32 and 33; T. 15 S. R. 67 W. Portions of Sections 4, 5, 6, 7, 8, 9, 10, 15, 16, 17, 18, 19, 20, 21, 22 and 29.

South Park Ranger District

- **Jefferson Lake Area:** T. 7S. R. 76W. Portions of Sections 10, and 11.
- **Jefferson Creek Recreation Area:** T. 7S. R. 76W. Portions of Sections 10, 11, 13, 14, 23, 24, 25 and 26.
- **Elevenmile Canyon Area:** T. 12S. R. 71W. a portion of Section 31; T. 13S. R. 72W. Portions of Sections 1, 2, 10, 11, 12, 14, 15, 16, 17, 20 and 21.

South Platte Ranger District

- **Harris Park:** T. 6 S. R. 73 W. Sections 13, 14, 15, 16, 17, 18, 20, 21, 22, 28 and 29. T. 6 S. R. 72 W. Sections 17, 18, 19 and 20.
- **Slaughterhouse Gulch:** T. 6 S. R. 73 W. Sections 27, 28, 33 and 34. T. 7 S. R. 73 W. Sections 1, 2, 3, 4, 9, 10, 11 and 12.
- **The AG Ranch:** T. 7 S. R. 73 W. Section 21.

Violations of these prohibitions are punishable as a Class B misdemeanor by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. § 551 and 18 U.S.C §§ 3559 and 3571).

- **Sugar Creek Road:** National Forest System (NFS) land within ½ mile of Sugar Creek Road (Douglas County road 67) from the junction with Douglas County road 97 to the junction with Douglas County road 40.
- **Christmas tree Area:** During Christmas tree cutting dates within T. 8 S. R. 70 W. Sections 19, 20, 21, 28, 29, 30, 31, 32, 33; T. 8 S. R. 71 W. Sections 22, 23, 24; T. 9 S. R. 70 W. Sections 4, 5, 6
- **Buno Gulch Area:** National Forest System land adjacent to NFSR118.E and Buno Gulch west of Park County road 62. T. 6S. R. 75W. portion of Section 13, all of sections 14 and 15.

PROHIBITED ACT:

1. Discharging a firearm, air rifle, or gas gun. 36 C.F.R. 261.58 (m).

EXEMPTIONS:

Pursuant to 36 C.F.R. Section 261.50(e), the following persons are exempt from this Order:

1. Persons with a USDA Forest Service permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State or local officer or member of any organized rescue or firefighting force engaged in the performance of an official duty.
3. Any person possessing a valid Colorado hunting license lawfully involved in hunting and harvesting game.
4. Any person using a paintball gun.

This Order will be in effect when signed and shall remain in effect until **June 15, 2019.**
