ORDER NO. 06-21-05-18-03

Pursuant to 16 USC. § 551 and 36 CFR § 261.50 (a) and (b), and to provide for public safety, the following acts are prohibited within the Sullivan Lake Ranger District of the Colville National Forest. This Order is effective beginning July 09, 2018 until July 27th, 2018 unless terminated earlier because the Diamond City Stream Restoration project has been completed.

PROHIBITIONS:

1. **Going into or being upon National Forest Land**, within the closure area, as described below and displayed on the attached map [36 CFR 261.53(e)]
2. **Being on a road**, within the closure area, as described below and displayed on the attached map [36 CFR 261.54(e)]

CLOSURE DESCRIPTION:

Area: National Forest Land east of county road C-3503 (West Branch LeClerc Road) and north of NFS road 1935115 (Hanlon Cutoff Road) and within section 18, T 36 N, R 44 E. See attached Map, Exhibit A.

Roads: All travel is prohibited on the the following National Forest National Forest System (NFS) Roads: 1935105 and 1933112 (existing closed road). See attached Map, Exhibit A.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.


