FOREST ORDER No. 06-03-00-18-07

## Public Use Fire Restrictions

Pursuant 16 U.S.C. 551 and to 36 CFR 261.50 (a) and (b), the following acts are prohibited on the Gifford Pinchot National Forest lands within the State of Washington. These temporary prohibitions will become effective August 3, 2018 and will remain in effect until December 31, 2018, or until rescinded.

### PROHIBITION:

- 1) **Building, maintaining, attending, or using a fire, campfire or stove fire** [36 CFR 261.52 (a)]. This includes a charcoal fire and pellet fire.
- 2) **Smoking, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable material.** 36 CFR 261.52 (d)
- 3) **Operating an internal combustion engine** [36 CFR 261.52 (h)]

### EXEMPTIONS:

Pursuant to 36 CFR, Sec. 261.50 (e), the following persons are exempt from this order:

- 1) Any Federal, State, County or Forest officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- 2) Persons with a permit specifically authorizing the otherwise prohibited act or omission
- 3) Fires are allowed in campfire rings or grills established by the Forest Service only at developed recreation sites listed in Exhibit A.
- 4) Pressurized liquid or gas fueled stoves, or lanterns are permitted
- 5) Portable generators within the developed recreation sites listed in Exhibit A are permitted under the internal combustion engine prohibition.
- 6) Motor vehicles and motor boats are permitted

### AREA DESCRIPTION:

This area affects National Forest System lands within the exterior boundary of the Gifford Pinchot National Forest including Mount St Helens National Volcanic Monument.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violation of these prohibitions is punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. 551 and 18 U.S.C. 3559 and 3571)
