COAL HOLLOW FIRE TEMPORARY
AREA CLOSURE ORDER

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b), **the following acts are prohibited** on the National Forest System area as described in this order. The area affected is all within the Spanish Fork Ranger District, Uinta-Wasatch Cache National Forest. This order is in effect August 13, 2018 through September 30, 2018 or until rescinded.

1. **Being in or upon the area** as described below and shown on the attached map. This includes all pedestrian, equestrian, bicycle and any type of motorized vehicle.
[36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

The southeast side of Diamond Fork Road (Forest Service road #029) from Junction of Utah State Highway 6 to the Diamond Fork road (Forest Service road #029) and Springville Crossing Junction. The South side of Forest Service road #051 road from Springville Crossing to Ray Valley Road (Forest Service road #051). West side of Ray Valley road (Forest Service road #051) to Unicorn ridge. South side of Forest Service road #042 from Unicorn ridge to Strawberry Ridge road (Forest Service road #043). The west side of the Strawberry Ridge road (Forest Service road #043). South west side of Forest Service road #131 to Solider Summit and Utah State Highway 6 junction. Northside of Utah State Highway 6 from Solider Summit to Diamond Fork road (Forest Service road #029) the closure includes all roads, trails, trailheads and campgrounds located in Township 9 South, Range 4 East, Sections 1, 2, 10 - 16, and 21 - 29; Township 9 South, Range 5 East, Sections 1 - 30 and 32 - 36; Township 10 South, Range 5 East, Sections 2 and 3; Township 8 South, Range 5 East, Sections 1, 2, 11 - 14, 23 - 27, and 31 - 36; Township 8 South, Range 6 East, Sections 6, 7, 17 - 20, and 29 - 32; Township 9 South, Range 6 East, Sections 5 - 8, 3 - 15, and 17 - 36; Township 10 South, Range 6 East, Sections 1 -18, and 24; Township 10 South, Range 7 East, Sections 4 - 11, 13 - 24, and 29 - 31; Township 10 South, Range 8 East, Sections 13 and 19 all within the Salt Lake Based Meridian and Township 5 South, Range 12 West, Section 25; Township 5 South, Range 11 West Section 30 all located within the Uintah Based Meridian as shown on attached map.


PURPOSE:

Purpose of the closure is to provide for public health and safety while fire personnel and equipment are suppressing the Coal Hollow Fire.

IMPLEMENTATIONS:

1. This Order will be in effect when signed August 13, 2018 through September 30, 2018 and shall remain in effect until rescinded.
2. Attached map shows the areas affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
