Walk-In Areas for Turkey Hunting Season

Pursuant to Title 36 CFR Section 261.50(a) and (b), the following acts or omissions are prohibited for designated Turkey Hunting Season's Walk-In Areas on the lands within the Bienville National Forest.

Operating any Motor Vehicle [36 CFR 261.54(d)]

This closure order is effective from September 2017 until rescinded by Forest Supervisor.

In cooperation with the Mississippi Department of Wildlife, Fisheries, and Parks (MDWFP), the following roads/routes have been selected as walk-in areas during Turkey Hunting Season. Turkey Hunters operating any Motor Vehicle during Turkey Hunting Season set by MDWFP is prohibited from the following:

FS 506A (1.3 mile from FS 506 to dead end of road)

FS 506C (1.2 mile from posted closure order to dead end of road)

FS 507A-2 (1.0 mile from posted closure order to dead end of road)

FS 507C (1.0 mile from FS 507 to dead end of road)

FS 517B (1.3 mile from posted closure order to dead end of road)


FS 532A (1.7 mile from Road 506-3 to dead end of road)

FS 547C (1.2 mile from posted closure order to dead end of road)




Road Closures: Smith County

Recreational and Historical Sites, Facilities, and Structures

Pursuant to Title 36 CFR Section 261.50(a) and (b), the following acts or omissions are prohibited on ALL Recreational and Historical Sites, Facilities, and Structures on National Forest Lands of the Bienville Ranger District including Marathon Lake, Greentree Reservoir, Shongelo Lake, Shockaloe Horse Trail Base Camps 1 and 2, Moore and Clear Springs Lookout Towers, any water control structures, and other areas or facilities designated for authorized personnel only.

This closure order is effective from September 2017 until rescinded by Forest Supervisor.

Motor Vehicle Usage and Parking

- (1) Possessing or utilizing any Motor Vehicle off of designated Forest Development Roads. 36 CFR 261.56
- (2) Operating or parking a motor vehicle on dams or levees. 36 CFR 261.58(g)
- (3) Possessing, parking, or leaving more than (2) vehicles, except motorcycles or bicycles per campsite. 36 CFR 261.58(i)
- (4) Operating motor vehicle in excess of 15 MPH inside developed recreation area. 36 CFR 261.54(d)
- (5) It is prohibited to operate an ATV/UTV within a recreation area/site. 36 CFR 261.56
- (6) It is prohibited to operate an ATV/UTV within an archeological or historic area/site. 36 CFR 261.53(c)

Lakes and other Water Bodies

- (7) Entering or being in a body of water, except within a designated swimming area. 36 CFR 261.58(k)
- (8) Being in the swimming area after sundown or before sunrise. 36 CFR 261.58(l)
- (9) Water-skiing or jet skiing is prohibited. 36 CFR 261.58(o) **and** 36 CFR 261.58(n)
- (10) All Lakes are “No Wake” for operating watercraft. Speed of no more than 10 MPH is authorized. 36 CFR 261.58(q)
- (11) Fishing without a valid state fishing license. 36 CFR 261.58(v)
- (12) Possessing or operating a motorboat or other watercraft that is required by the state to be licensed and/or registered. 36 CFR 261.58(k)(n)
- (13) Storing or leaving boats or rafts is prohibited. 36 CFR 261.58(p)
- (14) Entering or tampering with water control structures is prohibited. 36 CFR 261.53(e)

Camping and Firearms


- (15) Camping for a period longer than fourteen (14) consecutive nights. 36 CFR 261.58(a)
- (16) Being in the area between 10:00 PM and 6:00 AM is prohibited except for a person who is camping or is visiting a person camping in that area. 36 CFR 261.58(u)
- (17) Having more than ten (10) persons occupying a campsite. 36 CFR 261.58(f)
- (18) Discharging a firearm, air rifle, or gas operated gun is prohibited. 36 CFR 261.58(m)
- (19) Hunting is prohibited in recreation areas. 36 CFR 261.58(v)

Pursuant to 36 CFR 261.50(e), the following persons are exempted from the above prohibition:

- (1) Persons with permit from the Authorized Officer specifically authorizing an otherwise prohibited act or omission.
- (2) Any Federal, State, or Local officer engaged in the performance of an official duty.

- (3) Any authorized person engaged in official administrative duties regarding National Forest Administration.
