### OCCUPANCY AND USE

Pursuant to Title 36 C.F.R, 261.50 (a) and (b), it is hereby ordered that the prohibitions hereinafter set forth apply to all **Watershed Lakes**, as described below, within the **Holly Springs National Forest**, administered by the National Forests in Mississippi. See attached map.

Pursuant to 36 CFR, Section 261.50 (e) the following persons are exempt from the above prohibition:

- (1) Persons with a permit specifically authorizing the otherwise prohibited act or omission
- (2) Any Federal, State or Local Officer or member of an organized Rescue or Fire Fighting force in the performance of their official duty.
- (3) Any authorized person engaged in official administrative duties regarding National Forest Administration.






