The Beaverhead-Deerlodge National Forest will be filling multiple temporary/seasonal fire positions for the upcoming 2019 fire season. Openings are available at the GS-3, GS-4, and GS-5 levels. These are TEMPORARY/SEASONAL wildland fire positions with a maximum six-month tour of duty (not to exceed 1039 hours). The anticipated starting dates for these positions are mid-April to early June 2019.

HOW TO APPLY: All applications need to be submitted through the website at www.usajobs.gov. Be sure to indicate the duty locations at which you are interested in working.
