SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
SALT LAKE RANGER DISTRICT

TEMPORARY TRAIL AND TRAILHEAD CLOSURE

PROHIBITION:

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System trail described in this order. The trail affected is located on the Salt Lake Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting September 24, 2018 through October 30, 2018 or until rescinded.

1. **Being in or upon** the Cecret Lake trail (Forest Service trail #1010) and trailhead as described below and shown on attached map. This includes all pedestrian, hikers and mountain bikers. [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIPTION:

Cecret trail (Forest Service trail #1010) is closed from the Cecret Lake trailhead to Cecret Lake located in Township 3 South, Range 3 East, Section 26 all within the Salt Lake Base Meridian. As shown on the attached map.


PURPOSE:

Purpose of the closure is to provide for public health and safety while Salt Lake Public Utilities is doing dam maintenance at Cecret Lake.

IMPLEMENTATION:

1. This Order will be in effect when signed September 24, 2018 and shall remain in effect until October 30, 2018 or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
