Travel Management

Introduction

This appendix documents the project-level travel analysis decisions for proposed National Forest System (NFS) roads. A Travel Analysis was conducted in support of the Prince of Wales Landscape Level Analysis (POW LLA) Project. The recommended operational and objective maintenance levels, and a proposed travel management strategy for each road were assigned. The project travel analysis is found in the project record.

The POW LLA Project Final Environmental Impact Statement (FEIS) incorporates by reference the decision on the Access and Travel Management Plan Environmental Assessment for Prince of Wales and Surrounding Islands (USDA Forest Service, 2009, as amended). That document will continue to guide travel management within the project area, and no changes to objective maintenance levels for existing roads are proposed as part of the POW LLA Project. Designated routes and areas are reviewed annually and when approved changes are implemented. The Motor Vehicle Use Map (MVUM) shows the designated routes and areas along with class of vehicles authorized and, if appropriate, times of year for which use is authorized. The annual review of the Access and Travel Management Plan will be conducted as described in Appendix 2 of the POW LLA Project Draft Record of Decision (ROD).

Road management incorporates the following three key elements: Operational Maintenance Level (OPML), Objective Maintenance Level (OBML), and Travel Management Strategy. Together these elements describe level of service, maintenance requirements, and allowable traffic. Each road segment is assigned all three elements.

Roads will initially be managed under the assigned OPML. When the initial use period is over, the OBML is assigned and appropriate on-the-ground measures will be implemented. Initial use period includes commercial timber haul and a 3- to 5-year period for firewood or biomass removal. A review of roads will be conducted during implementation planning to identify roads that may cause safety or resource concerns. This review will ensure that no more than minor effects to resources will occur due to road storage deferment. Travel management strategies are implemented after initial commercial use is completed. In the case of road storage, decommissioning or hiking trail, these will be incorporated after the 3- to 5-year period for firewood or biomass collection.

Road Maintenance Levels

Maintenance Level defines the level of service provided by, and maintenance required for, a specific road, consistent with road management objectives and maintenance criteria. Maintenance Level 1 roads are considered closed to vehicle traffic. Maintenance Level 1 roads may be dual designated as Motorized Trails. Maintenance Levels 2 through 5 are considered open and drivable. Maintenance Levels for roads in this project analysis include Maintenance Levels 1 and 2:

- Maintenance Level 1: assigned to intermittent service roads during the time they are closed to vehicular traffic. The closure period must exceed 1 year. Basic custodial maintenance is performed in order to keep damage to adjacent resources to an acceptable level and to perpetuate the road to facilitate future management activities.
- Maintenance Level 2: assigned to roads open for use by high-clearance vehicles. Passenger car traffic is not a consideration.

Operational Maintenance Level is the Maintenance Level currently assigned to a road, considering today's needs, road condition, budget constraints, and environmental concerns. It defines the level to which the road is currently being maintained. It reflects the current condition and the ability to drive on the road.

Objective Maintenance Level is the Maintenance Level to be assigned at a future date, considering road management objectives, traffic needs, budget constraints, and environmental concerns. The OBML may be the same as, or higher or lower than, the OPML.

Travel Management Strategies

Travel management designations define the allowable traffic, if any, on NFS roads. Within the project area, Travel Management Strategies for project area roads include the following:

- Highway Legal Vehicle Only – these roads are open only to motor vehicles licensed under state law for general operation on all public roads within the state.
- Open to All Vehicles – these roads are open to all motor vehicles, including smaller off-highway vehicles that may not be licensed for highway use, but not vehicles that are oversized or overweight under state traffic law.
- Seasonal Designation – these roads are open only during certain portions of the year.
- Motorized Trail – these trails are open only to motor vehicles less than 50 inches in width at the widest point on the vehicle.
- Storage – each drainage structure is evaluated to determine the appropriate storage strategy, which includes doing the following: drainage structures may be removed or bypassed with water bars to restore natural drainage patterns; additional water bars or rolling dips may be added to control runoff; and apply seed and fertilizer to disturbed soil and exposed cutbanks. This is intended to be the primary maintenance strategy applied on intermittent use roads during their closure cycle. Maintenance Level 1, closure and basic custodial maintenance, is assigned. Roads in storage may be dual designated as motorized trails during the storage cycle.
- Decommission – this takes the road out of the National Forest Transportation System. Decommissioning roads involves restoring roads to a more natural state. Activities used to decommission a road may include, but are not limited to, the following: reestablishing former drainage patterns, stabilizing slopes, restoring vegetation, blocking the entrance to the road, installing water bars, removing culverts, reestablishing drainage-ways, removing unstable fills, pulling back road shoulders, or other methods designed to meet the specific conditions associated with the unneeded road. No motorized access is allowed.
- Hiking Trail – this takes a road out of the National Forest Transportation System as an NFS road and places it into a recreational trail. No motorized access is allowed.

Decision

The project Travel Management identified the key resource issues, along with the risks and benefits for each resource. The key resources included are aquatics (fisheries, hydrology, and soils), wildlife, commercial timber, precommercial thinning, subsistence, recreation, and non-NFS lands access. A Travel Management Strategy, OPML, and OBML were assigned to the analyzed roads.

The following table identifies the Travel Management Strategy, OPML, and OBML assigned for each proposed road. These elements are incorporated into the Draft Record of Decision for NFS roads to be constructed.
