Attached is the Timber Sale Program for the Hiawatha National Forest. It includes proposed timber sales to be offered during the period of October 1, 2018 to September 30, 2019. This program is identified so you will know the approximate amount and variety of timber ready to offer for harvest during the coming year. The information contained in this program should enable you to select, examine, and bid on those sales that best suit your operations.

Sales listed with a decision date are "Firm" and have an approved environmental document and will be offered as scheduled.

**Timber sales listed as "Stewardship contracts" or "potential Stewardship contracts" will be identified in the sale name of this sale announcement. Stewardship contracts are a tool available to the Forest Service to enhance and restore landscapes by using the value of traded goods (timber) for important work on the ground (services). The Stewardship contract prospectus will describe both the timber sale information and the service contract specifications. Potential purchasers are encouraged to seek additional information and consider this non-traditional method of procuring Forest Service timber. These types of contracts will be awarded on a best-value basis.**

This announcement lists the estimated volumes in cubic measurements. For purposes of converting CCF (hundred cubic feet) in this report to MBF (thousand board feet) and Cords, use the following approximations:

Sawtimber CCF multiplied by .54 = Sawtimber MBF

Pulpwood CCF divided by .79 = Pulpwood Cords

**At present, we have established no Small Business Administration set-aside sales.**
