

ORDER
COCONINO NATIONAL FOREST
MOGOLLON RIM RANGER DISTRICT
C.C. CRAGIN (BLUE RIDGE) RESERVOIR
Public Health and Safety

PROHIBITIONS:

Pursuant to 36 C.F.R. § 261.50(a) and (b), the following acts are prohibited within the area and on the road described in this Order, all within the Mogollon Rim Ranger District, Coconino National Forest:

1. Operating a motorized vehicle on the road in excess of 22 feet in length or in excess of 50 feet total for a vehicle and attached trailer (vehicles will be measured from front to rear bumper, excluding hitch or bumper attachments); **36 C.F.R. § 261.54(d)**
2. Parking or leaving a vehicle in violation of posted instructions; **36 C.F.R. § 261.58(g)**
3. Entering or being in a body of water within 50 feet of any portion of a boat launch ramp or dock; **36 C.F.R. § 261.58(k)**

EXEMPTIONS:

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
2. Salt River Project (SRP) personnel, and any state contractors, conducting official business with regard to the maintenance and construction of facilities in and adjacent to the C.C. Cragin (Blue Ridge) Reservoir or the monitoring of Reservoir resources.
3. Person(s) with a written Forest Service authorization specifically exempting them from the effect of this Order.

AREA AND ROAD DESCRIBED:

The portion of Forest System Road (FR) 751 starting at the intersection of FR 751 and FR 751a and following FR 751 approximately 3.35 miles southeasterly to the termination of the public road access, including the boat launch area at FR 751 and the C.C. Cragin Reservoir. Parking or leaving vehicles in

violation of posted signs in the boat ramp area and bathroom/parking area is prohibited (see “Authorized Parking Areas” on the map in Exhibit A). Swimming is prohibited within 50 feet of any portion of a boat launch ramp (see “Swimming Restricted Area” on the map in Exhibit A).

PURPOSE:

The Mogollon Rim Ranger District has determined that restrictions on vehicle lengths, parking, and swimming near the boat launch ramp are necessary at the C.C. Cragin (Blue Ridge) Reservoir in order to provide for public health and safety and to ensure that emergency vehicles and first-responders have effective access to respond to emergencies. *See* 36 C.F.R. § 261.53(e)

IMPLEMENTATION:

1. This Order will be in effect at 8:00 AM on the date signed and shall remain in effect until April 19, 2020 or until rescinded, whichever occurs first.
2. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for individuals, and \$10,000.00 for organizations and/or imprisonment for not more than six (6) months (*see* 16 U.S.C. § 551, 18 U.S.C. § 3571(b)(6), 18 U.S.C. § 3581 (b)(7)).

4. This Order supersedes any previous orders prohibiting the same acts covered by this Order.




