SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
HEBER-KAMAS RANGER DISTRICT

TEMPORARY AREA AND ROAD CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50(a) and (b), the following acts are prohibited on the National Forest System area and road described in this Order. The area and road affected are located on the Heber-Kamas Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting June 15, 2019 until the completion of the Far West salvage timber sale or until rescind.

1. Being in or upon the area of the Far West salvage timber sale and Forest Service road #026 as described below and as shown on attached map. This includes all pedestrian, equestrian, bicycle and any type of motorized vehicle. [36 CFR 261.53 (e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

The Far West salvage timber sale area located in Township 1 South, Range 11 West, Sections 3, 4, 5, 6, 32, 33, and 34 all within the Salt Lake Based Meridian as shown on attached map, including Forest Service road #026 from the junction with Forest Service road #901 located in Township 1 South, Range 7 East, Sections 5 and 33 all within Salt Lake Meridian as shown on map.


PURPOSE:

Purpose of the closure is to provide for public health and safety while timber crews are cutting and removing timber as part of the Far West salvage timber sale.

IMPLEMENTATION:

1. This Order will be in effect when signed June 15, 2019 and shall remain in effect until the completion of the Far West salvage timber sale or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
