**ORDER**

Pursuant to Title 36 Code of Federal Regulations (CFR) 261.50(b) the following acts are prohibited within the designated Closure Area and any on designated portions of National Forest Service Roads and Trails and within the Closure Area, as shown on the attached map, within the Idaho Panhandle National Forests. These restrictions are in addition to those general prohibitions in Title 36 CFR, Part 261, Subpart A, become effective **July 8, 2019**, and will remain in effect until rescinded. The following is prohibited by law:

1. Being on the road. [Title 36 CFR 261.54(e)]

**Road closures:**


Being on or using Road #406 Hayden Lake Divide from the intersection of Road #612 (Deception creek road) at Windy Ridge to the junction with Road #206 (Railroad grade road) at Burnt Cabin Summit.

**EXEMPTIONS**

Pursuant to Title 36 CFR 261.50(e), the following persons are exempt:

1. Persons with specific written authorization for the otherwise prohibited act or omission.
2. Any Federal, State, or local officer or member of an organized rescue or fire fighting force in the performance of an official emergency duty. Report all emergency access to the Coeur d'Alene River District Ranger as soon as possible.
3. Federal or State administrative personnel in the performance of an official duty.
4. Contractor and his personnel in the performance of their duties.

**RATIONALE:** This Closure is necessary for public health and safety while road reconstruction, for the purposes of vegetation management and restoration activities.

**PENALTY:** Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. (16 U.S.C. 551 and 18 U.S.C 3559 and 3571)


