St. Joe Ranger District, St. Maries, Idaho Order No. 01-04-04-19-001

ORDER

Pursuant to Title 36 Code of Federal Regulations (CFR) 261.50(b) the following acts are prohibited on designated portions of National Forest Service, roads, and trails, described in this order as shown on the attached map, within the St. Joe Ranger District of the Idaho Panhandle National Forests. These restrictions are in addition to those general prohibitions in Title 36 CFR, Part 261, Subpart A, become effective **July 30th, 2019**, and will remain in effect until rescinded.

1. Prohibited to go into or be upon any area which is closed for the protection of Public Health and Safety. [36 CFR 261.53(e)]
2. Being on the road. [36 CFR 261.54(e)]

Road closure:


- Road 3781 (Garnet Area road) from its intersection with road 447 (East Fork Emerald creek) to its termination
- Road 3781-b from its take off from 3781 (Garnet Area road) to its termination

EXEMPTIONS

Pursuant to Title 36 CFR 261.50(e), the following persons are exempt:

1. Persons with specific written authorization for the otherwise prohibited act or omission.
2. Any Federal, State, or local officer or member of an organized rescue or fire fighting force in the performance of an official emergency duty. Report all emergency access to the St. Joe District Ranger as soon as possible.
3. Federal or State administrative personnel in the performance of an official duty.
4. Contractor and his personnel in the performance of their duties.

RATIONALE: These Closure restrictions are due to construction activities occurring and are necessary for the protection of public health and safety.


PENALTY: Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 U.S.C. 551 and 18 U.S.C 3559 and 3571).

NOTIFICATION: A copy of this order shall be posted in the Forest Supervisor's Office, each District Ranger's office and other appropriate locations as prescribed under Title 36 CFR 261.51.
