SPECIAL ORDER OF FOREST SUPERVISOR  
UINTA-WASATCH-CACHE NATIONAL FOREST  
HEBER-KAMAS RANGER DISTRICT

**TEMPORARY AREA, ROADS AND TRAILS CLOSURES**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on the National Forest System area, roads and trails as described in this order. The area, roads and trails affected are located all within the Heber-Kamas Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect when signed September 13, 2019 and shall remain in effect until November 30, 2019 or until rescinded. The closure will be in effect two days prior to the prescribed burn, during the prescribed burn and two days after completion of the prescribed burn.

1. **Being in or upon the area, roads and trails** as described below and shown on the attached map. This includes all pedestrian, equestrian, bicycle and any type of motorized vehicle. [36 CFR 261.53(e)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIBED:**

The area, roads and trails closure starts at the junction of Mirror Lake Highway, State Route 150 and Upper Setting road (Forest Service road #034) then goes north on the Upper Setting road to the junction of Upper Setting trail (Forest Service trail #238) east to the junction of Big Elk Lake trail (Forest Service trail #203) south on Norway Flats road (Forest Service road #035) to the Mirror Lake Highway, State Route 150 then west to Upper Setting road this includes the Shingle Creek trail/drainage (Shingle Creek trail #235) and Erickson Basin trail (Forest Service trail #211) located in Township 2 South, Range 7 East Sections 1, 11, 12, 13, 14, 15, 16, 21, 22, 23, 24, 25, 26, 27, 35, and 36; Township 2 South, Range 8 East, Sections 4, 5, 6, 7, 8, 9, 17, 18, 19, and 30 all within the Salt Lake Meridian as shown on the attached map.

**PURPOSE:**

Provide for public and firefighter safety during the implementation of Upper Provo prescribed fire.

**IMPLEMENTATION:**

1. This Order will be in effect when signed September 13, 2019 and shall remain in effect until November 30, 2019 or until rescinded.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
