We live in rural Cedar County, one mile from the waters of Stockton Lake and even closer to the Dade County line. We support the proposed ban of hunting feral hogs in the Mark Twain National Forest.

We have seen the rooting damage caused by a small number of feral hogs. In one instance, it looked like they almost succeeded in digging up a mature oak tree with a trunk of about 20" diameter; it was shocking. My sister came upon a sounder with at least two sows and a bunch of piglets; she feared they would attack her, but she stood still and they did not.

While walking our property, my husband saw a fox cross the trail where he was walking. When the fox saw him, it dropped what it was carrying in its mouth, half a piglet. While turkey hunting in a tree blind, my nephew often sees a few pigs. We report our sightings to our local conservationists, but we also have a problem with local hunters preferring to shoot them and scatter the sounder. Feral hogs are invasive, destructive, and are a threat to our natural resources. Please ban the hunting of feral hogs in the national forests in order to expedite their elimination from Missouri through proven trapping and removal techniques.





Dear Sir/Madam

East Ozarks Audubon Society's membership comes from a six-county region of the Ozarks; we therefore are very interested in Forest Service management issues. On behalf of our organization, I wish to express our full support for banning hog hunting within Missouri's National Forest lands: this is clearly the first step in the goal of eradicating wild hogs from Missouri.

From a birding perspective, the increasing numbers of hogs over the last two decades has been a disaster—all ground-nesting species are suffering from the omniverous diet of wild hogs. This includes many migratory warbler species (such as Ovenbirds and Louisiana Waterthrush), killdeer, ducks and even turkeys. Even the sport of hunting is being compromised by hogs: birders searching woods and grasslands are not infrequently encountering wild hogs!

We are equally concerned about the damage being done to native fauna by hogs—they are destroying hilltop glades, prairies, and riparian areas.

Hog hunting is not a "traditional sport" in the Ozarks—despite what some uninformed politicians are saying—especially as wild hogs are not a native species. There was a time when Missouri allowed livestock to roam freely but that practice was ended long ago. It is our opinion that those who want to sell hunting rights on their private property should be required to fence off their land. Clearly the National Forest should not be a breeding ground for those few nearby landowners who seek to profit from an overabundance of hogs in the Ozarks. And those unscrupulous hunters who intentionally trap and then release young female hogs need to be prosecuted.

We hope Mark Twain National Forest will soon follow the example set by Missouri's Department of Conservation and ban hog hunting. Only then can an intensive program of hog eradication be successful.



Please include this letter from the L-A-D Foundation and Pioneer Forest in the record of public comment regarding the proposed prohibition on feral hog hunting on the Mark Twain National Forest.

Pioneer Forest, at more than 143,000 acres, shares significant boundary lines with the Mark Twain National Forest. The continued spread of feral hogs from the Mark Twain—especially when scattered by hunters and their dogs—to our lands and those of other neighbors poses a serious threat. We have experienced severe damage to natural areas and forest reserves as well as on glades and along streams. In cooperation with the Missouri Feral Hog Partnership, we have prohibited hog hunting on our lands and concentrated on trapping, removing hundreds of hogs each year. Yet we continue to find populations in new areas. If the Mark Twain does not act to prohibit hog hunting, the work of the Feral Hog Partnership will likely be seriously deflated and hogs will have free range in Missouri, with the greatest damage to Missouri's \$88 billion agricultural sector yet to come. We commend and strongly support your proposed prohibition on hunting of feral hogs on the national forest.

In the Gulf states and neighboring Arkansas and Oklahoma, where the hog hunting culture is strong, feral hogs have mushroomed beyond control. That is not what Missouri wants. Tennessee's experience suggests a positive direction. The state prohibited hunting of feral hogs until it yielded to political pressure in 1999, after which it took just ten years for hogs to spread statewide. Officials reinstated the ban, concentrated on trapping, and now report success in eradicating the new populations. Kansas and Nebraska have also kept hogs under control by trapping and prohibiting hunting.

Here in Missouri, the Department of Conservation prohibited hunting on MDC lands in 2016 and the Feral Hog Partnership adopted a statewide strategic plan for hog eradication by and with the support of an enhanced corps of professional trappers. The strategy has shown the most success so far in the Stockton-Pomme-Truman Reservoir area, where there is no Mark Twain land and hunting is now prohibited on all public lands. It has also been successful in eliminating pockets of feral hogs in northern Missouri counties (Harrison, Clark, Saline, Callaway, and Gasconade), creating a sizeable hog-free zone. This demonstrates how Missouri will get the job done.

We know that decades of both hunting and trapping did NOT work in Missouri, and it certainly has not worked in states farther south. With other public agencies and national forests to the north and east looking to the Mark Twain, it is critical that you resist the political pressure of a small group of hog hunters and the politicians they have so effectively lobbied. Missouri's wildlife and hunting legacy and its high quality and abundant public (and private) lands are at stake. It is time to put the political lobbying aside and move forward with professional management actions we know will work.






The Forest Service should not be in the business of promoting exotic animal hunting yet that is what has been happening with the policy of allowing unlimited hog hunting. Only a small number of hogs are killed by sport hunters and, worse, large numbers of hogs are being dispersed widely. This has been bad for landowners, bad for native vegetation, and bad for the wildlife.

Hog hunting is not a “traditional sport” in Missouri any more than hunting giraffes would be: the hogs are not native! Even worse, wild hog hunting has become a commercial operation for some area property owners who lease their land for those who want to hunt hogs—having the Forest Service serve as the breeding grounds becomes even worse when paying guests can cross onto Forest Service land and freely hunt there.

The Forest Service needs to work with the Missouri Department of Conservation and intensify trapping and overhead shooting.


