SPECIAL ORDER
Camping Restriction

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) the following act is prohibited in the area as described in this order, all within the Powell Ranger District, Dixie National Forest until further notice.

No camping is allowed within the area described in this order and identified on the attached map. [Title 36 CFR 261.58 (e)]

DEFINITIONS:

Camping: the temporary use of National Forest System Lands for the purpose of overnight occupancy without a permanently-fixed structure.

EXEMPTIONS:

Pursuant to 36 CFR 261.58 (e) the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

AREA DESCRIBED:

Dave's Hollow: N $\frac{1}{2}$ NW $\frac{1}{4}$ Sec 20; North $\frac{3}{4}$ of Sec 19, T. 36 S, R 3 W; S $\frac{3}{4}$ Sec. 13, Sec. 24, NW $\frac{1}{4}$ Sec. 25, area east of road 088 in Sec. 26, area south and east of road 088 in section 34, area east of road 088 and south of road 096 Sec. 35, T 36 S, R 4 W. Section 2 within the forest boundary and section 3 east of East Creek, T 37 S, R4W. Salt Lake Base Meridian.

PURPOSE/DURATION:


This order is intended to allow resource protection and proper management of National Forest Lands and the adjacent private and National Park Service lands.

This order will be in effect when signed and shall remain in effect until October 31, 2021 or until rescinded, whichever is earlier.

IMPLEMENTATION:

1. A map identifying the closure area is attached and made part of this Order, Exhibit A.
2. Violation of the above prohibition is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571 (b)(6), Title 18 USC 3581 (b)(7)].

4. This order supersedes any previous order(s) prohibiting the same, or similar acts prohibited by this order on roads covered by this order.
