Tammy Randall-Parker, the Forest Supervisor for Inyo National Forest, Pacific Southwest Region, signed the Record of Decision (ROD) for the revised Land Management Plan for the Inyo National Forest on October 21, 2019. The final ROD documents the rationale for approving the 2019 Land Management Plan and is consistent with the Reviewing Officer's response to objections and instructions.

The revised Land Management Plan for Inyo National Forest will become effective 30 days after the publication of the Notice of Plan Approval in the *Federal Register* (36 CFR 219.17(a)(1)), which is expected on October 25, 2019.
