

**WHY ARE CLOSURES NEEDED?**



Local Natural Resource Managers and Wildlife Managers believe threats to big game winter range and calving areas may be negatively impacting the herds in northwestern Colorado.



Recreational disturbance in big game winter range may result in elk and deer herds being pushed out of these areas and into areas of potential conflict, including residential developments, hay fields and highways.



Specific areas of the Routt National Forest are important winter range and spring calving areas for resident elk herds.



On the Routt National Forest, big game winter range is found on lower elevational, south-facing slopes with shallow snow depths, high solar exposure and is primarily covered in mountain shrub vegetation.



As big game winter range on private land become developed, public lands become more important for wintering elk herds and spring calving.



These closure areas provide pockets of habitat where elk find security and food during the winter months or during spring calving without being disturbed by human activities.

*Remember:* The Forest Service is enforcing a **MANDATORY WINTER recreation closure** from **December 1 - April 15** for trails listed on this brochure. A **MANDATORY SPRING closure** from **May 15 - June 15** is in place for trails on Buffalo Pass to protect important elk calving areas. Also, please respect **VOLUNTARY WINTER** closures on the Forest during December 1 - April 15.

Please help give the big game herds a break during these critical time periods.

**RECREATION AND CRITICAL ELK HABITAT**



This brochure contains a map of trails and areas CLOSED for elk winter range and elk spring calving near Steamboat Springs. Annual **winter closures** are in place from **DECEMBER 1 to APRIL 15** and annual **spring closures** from **MAY 15 to JUNE 15** at trails where conflicts between wildlife and people have historically occurred. Voluntary closures are currently being monitored for potential closures. Suggestions for alternate recreation areas have been provided below.
