*Area Closure*

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) the following act is prohibited within the area described in this Order, all within the Palisades Ranger District, Caribou Targhee National Forest. This area is closed from **December 15 through April 15<sup>th</sup>**, annually.

1. Allowing dogs in the area. **36 CFR 261.53(e)**.

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this Order:

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

**AREA DESCRIBED:**

All Groomed ski trails and area depicted on the map attached hereto as Exhibit A., in the Kelly Canyon area on the Palisades Ranger District, Caribou Targhee National Forest.

The above-described area is within the proclaimed and administrative boundaries of the Palisades Ranger District, Caribou-Targhee National Forest, Madison and Jefferson Counties Idaho.

**PURPOSE:**

These restrictions are necessary to protect the health and safety of Forest visitors. This closure is necessary to reduce sanitation issues associated with dog feces, mitigate user conflicts and alleviate maintenance costs associated with prohibited uses.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until April 15, 2030 or until rescinded, whichever occurs first.
2. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for individuals, and \$10,000.00 for organizations and/or imprisonment for not more

than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581 (b)(7)].

This Order supersedes any previous order(s) prohibiting the same acts covered by this Order.


