Prospective Timber Purchasers and Other Interested Parties:

The Forest Service intends to advertise timber designated for cutting on the Boise National Forest. This 6-month Timber Sale Program Announcement is for April 1 to September 30, 2020. This advanced notice is to afford interested parties time to examine the sale areas. You may obtain information and maps from the individual district contacts listed below or our webpage, [www.fs.usda.gov/detail/boise/landmanagement](http://www.fs.usda.gov/detail/boise/landmanagement). On the right hand side of the page under Quick Links, locate and select “Timber Sales” and click on the link for the Periodic Timber Sale Announcement. The official timber sale advertisement notification will contain minimum bid rates, bidding provisions and other sale conditions. More detailed information concerning each timber sale can be obtained at the time of advertisement, by contacting the individual Ranger Districts, or the Idaho Department of Lands for any Good Neighbor Authority (GNA) sales.

Below is a summary for each of the planned sales. At present, the Boise National Forest is planning on offering two timber sales as small business set-aside sales.
