## VISITOR'S PERMIT

(Ref. FSM 2323)

### (15) RULES, REGULATIONS, AND BEST PRACTICES

-This permit is for camping on Forest Service Land Only. 14-day maximum stay limit

-Carry a signed copy of permit with you

-Practice leave no trace camping techniques

-Pack it in, Pack it out: pack out all trash and bury human waste

-Dispersed camping occurs at least 50ft from water sources and 50ft from trails

-No camping in developed recreation areas - such as boat ramps, campgrounds and fishing lakes. No RV or car camping

-Campfires are not allowed if the state has issued a "Red Flag Warning"

-Visitors may only use dead and down wood. No cutting of live or dead standing trees

-You must be 1/2 mile from any road or parking lot before primitive camping with permit is allowed

### (16) REMARKS

Camping is for FS land only. FS land is marked in red boundary paint and user is responsible for distinguishing between FS and private land.
