UINTA-WASATCH-CACHE NATIONAL FORESTS  
LOGAN RANGER DISTRICT

TEMPORARY ROAD CLOSURE

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on the National Forest System road as described in this Order, all road affected are located within the Logan Ranger District, Uinta-Wasatch-Cache National Forests. This Order is in effect starting July 21, 2020 until July 21, 2021 or until further notice.

1. **Being in or upon the** Millville Canyon road (Forest Service road #168), with any type of motorized vehicles as described below and shown on attached map.  
[36 CFR 261.53(e)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIBED:**

The closure starts at the Millville overlook then goes north and east to Ferry Springs, located in Township 11 North, Range 2 East, Sections 21 and 28 all within the Salt Lake Based Meridian and as shown on the attached map.

**PURPOSE:**

Purpose of the closure is to provide for public health and safety due to a rock slide that has come down off the side of the hill and is blocking the Millville Canyon (Forest Service road #168) the area has potential for continued rock debris activity and while heavy equipment and crews are in the area working to remove debris and repair any road damage.

**IMPLEMENTATION:**

1. This Order will be in effect when signed July 21, 2020 and shall remain in effect until July 21, 2121 or until the repair work has been completed.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads or trails) covered by this Order.
