SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
OGDEN RANGER DISTRICT

CAMPGROUND AREA CLOSURE

PROHIBITION:

Pursuant to Title 36 CFR 261.50(a) and (b), **the following acts are prohibited** on the National Forest System described in this order. The affected campground is located on the Ogden Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting June 19, 2020 through October 31, 2020.

1. **Going into or being in the campground area** as described below and shown on attached map. This includes all pedestrian, equestrian, bicycle and any type of motorized vehicle. [36 CFR 261.54(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Jefferson Hunt campground area located in Township 6 North, Range 2 East, Section 18 all within the Salt Lake Based Meridian as shown on the attached map.

PURPOSE:

Purpose of the closure is to provide for public health and safety while crews and heavy equipment are decommissioning the Jefferson Hunt campground by removing all existing infrastructure including signs, restrooms, tables, site markers, fire rings, and any other foreign infrastructure associated with this developed campground and during rehabilitation work of re-seeding and scarification of the road leading into decommissioned campground.

IMPLEMENTATION:

1. This Order will be in effect when signed June 19, 2020 and shall remain in effect until, October 31, 2020 or until rescinded.
2. Attached map shows the area affected by this Order.
2. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].

4. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
