ORDER NO. 06-14-04-20-17
ROAD AND TRAIL CLOSURE

Pursuant to 16 USC 551, 36 CFR 261.50(a) and (b), the following acts are prohibited on roads and trails within the Pomeroy Ranger District of the Umatilla National Forest. These prohibitions are enacted because of storm damage. This order is effective starting July 24, 2020 and will remain in force until September 30, 2020 or the order is rescinded, whichever is sooner.

PROHIBITION:

1. Using any type of traffic prohibited by the order, this order specifically prohibits motor vehicles on Forest Service Road 47 from milepost 9.9 until terminus and the entireties of Forest Service Roads 4712 and 4713. 36 CFR § 261.54(a)
2. Use by any type of traffic or mode of transport prohibited by the order, this order specifically prohibits motor vehicles on the entireties of following Forest Service Trails: Meadow Creek Trail #3123, Panjab Trail #3127, and Rattlesnake Trail #3129. (See Exhibit A) 36 CFR § 261.55(c)

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Personnel with written authorization by a Forest Officer, which specifically authorizes the otherwise prohibited act or omission.
2. Any Federal, State, or local Officer or volunteer in the performance of an official duty.
3. Persons under a special use authorization that allows the otherwise prohibited activity, and approved contractors and their agents directly engaged in approved work outlined in an operating plan or permit.
4. Persons traveling into the closed area by non-motorized method including horse, mountain bike, or on foot.

These restrictions are enacted for public health and safety.


